Meeting called to order by Chairman Phil Christenson at 7:00PM, reminder to silence phones.

Pledge of allegiance.

Chairman Christenson, Supervisors Mark Quandt and Ahren Telford, Treasurer Ethel Firgens, and Clerk Kristen Telford present. 7 electors in attendance.

Review made of agenda/order of the day. Open meeting notice requirements met. Motion to approve the agenda made by A. Telford, seconded by Quandt. 3 ayes. Approved.

Review of the draft minutes from the October 14, 2025 regular meeting, the October 14, 2025 Lynn Court hearing, and the October 21, 2025 budget workshop. Motion to approve minutes made by Christenson, seconded by Quandt. 3 ayes. Approved.

Clerk Telford read correspondence highlighting property tax levies, election workers needed for the next election cycle, the new tax software, and historical documents.

Treasurer Firgens gave the expenditure and receipts report from last month showing a balance of \$82,962.71 in checking and \$163,061.02 in the money market.

Public Comment: Thanks for "atvs stay on pavement" signs on Bonita. Suggestion to move signs for winter to allow for snow grooming.

Gillett Area Ambulance Service Contract: Contract for 2026-2027 presented. Discussion on options and necessity. Costs for 2026 to be \$29,113.50. Costs for 2027 to be \$29,265.19. Motion to accept the Gillett Area Ambulance Service contract for 2026-2027 made by Quandt, seconded by A. Telford. 3 ayes. Accepted.

Oconto County Highway Department: Presented contract for 2026-2027. \$94,784.00 required to be spent annually. Motion to approve contract with Oconto County Highway Department made by Christenson, seconded by Quandt. 3 ayes. Approved.

Road Report: Ken Dolata approved \$2,500 in County cost sharing for the stone under Logan bridge. Total cost for stone projected \$3570. Stone will be done this year. Unsure if the rest of the bridge project will be done this year. Overlays on Hill Rd east and Hill Rd to the Breed town maintenance line done. Crack filling needs to be completed on Logan. Would like to

do overlays on Logan Rd by Pipeline Bar and Wild Turkey Ln in a future project. Gravel work done on N&S Pineview Lns, E Canoe Ln, Zaddock Ln., more loads on Blue Rd. Shoulder work on Bonita and various places around town. Grading/gravel done on Weso Creek Rd and Becker. Grading costs report showed In-Town grading compared to County grading a significant cost savings. Non-compliant signs replaced.

Recycle Center: The big roll-off dumpsters are gone until next year. Recycle Center is closed on Wednesdays until next April.

TCenergy grant has been received in the amount of \$2,681.92. AED, first aid kits, de-choker, CPR masks, and other items are ordered.

TextMyGov submitted a quote for services. Town already has a similar service already in place called HeyGov. TextMyGov services disregarded.

Budget Hearing next Tuesday November 18, 2025 at 6:00PM.

Review of the monthly bills to be paid. Motion to pay bills made by Christenson, seconded by A. Telford. 3 ayes. Carried.
