<u>DO NOT</u> put tax bills in the <u>FLAG DROP ONLY</u> box (white painted mailbox) at the stairs of the town hall. This could cause you delayed &/or late payments incurring interest & penalties.

Mail option for 1st installment & full payment due by January 31st:

Town of Byron Treasurer N3097 State Road 175 Byron, WI 53006 Enclose the appropriate payment stub(s) with your payment, located at the bottom of your tax bill.

Payments will be accepted in the form of check, cashier's check or money order (no cash).

ENDORSE ESCROW CHECK if made out to YOU (BOTH SIGNATURES) & TOWN OF BYRON.

If a return receipt is requested, include a self-addressed, stamped envelope.

Town of Byron does not process tax payments after February 1st.

They will be processed by FDL Co Treasurer's office.

WHAT IS CONSIDERD A TIMELY PAYMENT HAS CHANGED!

A payment is considered timely if it is mailed in a properly addressed envelope with a U.S. Postal Service postmark, before midnight of the due date. Due to government/USPS inefficiency of recent years, they have put out notice that items are **NOT POSTMARKED THE DAY THEY ARE RECEIVED** anymore. It can take up to 3 days to postmark an envelope! In your mailbox on December or January 31, will likely incur interest & penalties to your tax bill. Wisconsin state law requires the tax bill to be mailed to the <u>property owner of record on January 1</u> of the current year. If you are no longer the property owner of record, please contact your closing agent and/or title company.

Dog License are a requirement by State Statute: Wis. Stats. Chapter 174.05 – Dog license tax - requires all dog owners to pay a dog license tax and obtain a license for dogs over 5 months of age. Town of Byron Animal Control Ordinance - No person shall own or keep a "vicious dog(s)" in the Town of Byron.

Dog licenses are \$8.00 for male or female dogs, \$3.00 for spayed or neutered dogs. Kennel/Multiple dog license \$35 for 12 dogs, \$3 each additional dog. Proof of current rabies shots must accompany requests for dog license.

The deadline to license dogs and kennels is March 31, 2026. <u>Late fees do apply, for each dog after April 1, 2026.</u> Can be paid at time of tax collection to avoid late fees.

Any 2nd installments mailed to the town hall or made out to Byron are subject to interest & penalties incurred, due to wrong delivery address.
