From the Supervisor's Desk

A couple of days ago I received a call from a 69-year-old woman in Copake who asked how to sign up for a vaccination. She has no computer.

Right now we are in a very stressful time, as residents under the age of 65 worry that they cannot yet get a vaccination, and residents 65 and over struggle to navigate state, county and pharmacy websites, trying desperately to get an appointment for a vaccination. At this point, Columbia County has been vaccinating designated groups, such as grocery workers, but so far the county does not have vaccines to vaccinate the 65+ population. As they state on their website:

- NYS has directed that CCDOH **CAN ONLY** provide vaccine to people 65+ when vaccine doses provided by the state are designated specifically for this group (people 65+). Unfortunately, this is not every week and we have no control over when they will do so.
- The Federal government/NYS have directed that pharmacies be the primary provider of the COVID vaccine to 65+ people.

The best advice that I can give right now, based on my own experience, is that residents should, if they can, go online to check availability of appointments at pharmacies. I know that people have had luck getting appointments at CVS. My wife and I got appointments at Walgreens in Troy.

The problem with going online to make a pharmacy appointment is that, unlike when you want to get an airline ticket and you can go to a site - say Travelocity - to compare what is available with numerous airlines, with the vaccinations you have to go to each site individually. So, you need to go to Walgreens, register, and then try your luck. And if that doesn't work, go to CVS. It is cumbersome, inefficient, and very frustrating. You feel as if you are at a slot machine, each time thinking that you are about to win, only to see another notice of "no appointments available."

What I can pass along is this: First, do not make an appointment in Massachusetts or Connecticut. We did that, only to be advised just before the appointment that contrary to the earlier emails we were ineligible. My advice is that when you go to sign up, instead of using 12516 as the zip code, enter a location where you would like to go to be vaccinated. We entered Catskill, Hudson and then Albany; that is how we were able to make appointments in Troy. Second, it seems that the websites are loaded with new appointments on the hour; we got our appointment when we logged on at 7:00 Sunday morning.

Finally, the Town Board recognizes that the process of going online to pounce on an appointment before it disappears may be daunting for some, but impossible for others. If you are a senior citizen and you cannot go online to secure an appointment, here are a couple of avenues you can pursue. First, call the Columbia County Vaccine Hotline for information: 518-697-5560, Monday – Friday 9am-4pm. They can give you information and also take your name so that they can contact you if they have availability of vaccine in the weeks ahead.

Also, I am happy to announce that the newly formed Community Service Committee of the Copake Grange has reached out to me; they hope to be able to assist those who need help in making appointments for vaccines. You can check the Grange website for updates at copakegrange.org - or you may call and leave your name with the Town Clerk. Lynn Connolly will pass your name and contact information on to the Grange. If you are someone who wants to volunteer to help the Grange in this endeavor, please reach out to me personally.

On a happy note, the numbers in the county are finally dropping. There are no promises here, but we are going in the right direction. As of Wednesday, there were 277 active cases in the

county but only 10 new cases. There are still 27 individuals who are hospitalized, with 2 in the ICU. There have been 81 deaths.

Community Workshop for Copake Waterfront Plan

A second community workshop will be held online on Saturday, Feb. 13 from 10am to 11:30am to establish priority goals and projects to enhance the town waterways and hamlets.

The Town of Copake continues to make progress on the waterfront and community plan that seeks to maintain a high quality of life in Copake by increasing access to its main waterways: the Roeliff Jansen Kill, Bash Bish Brook and Taghkanic Creek. Funding has been provided by the New York State Department of State under Title 11 of the Environmental Protection Fund.

The planned online workshop on February 13, 2021 will focus on reviewing progress made on the plan to date, discussing the vision and goals, and soliciting the community's help in prioritizing projects for enhancing Copake's hamlets and waterways.

The draft vision, goals and projects, which were developed based on input at the first community meeting in February 2020, focus on building a healthy town where people of all ages and abilities have access to recreation and waterways, sustaining our longstanding and essential bonds with nature and with our heritage, enriching our lives in vibrant hamlets safely linked by land and water, and adapting with resilience to changes and challenges.

The workshop will be held as an online Zoom meeting through the project website: www.copakewaterfronts.com. You can also access the link on the town website: www.townofcopake.org.

All residents and interested parties are encouraged to participate as the town seeks to solicit widespread input on the Waterfront and Community Revitalization Plan. Solar Update

As you may have heard, Hecate announced that battery storage facilities would not be included in the proposed Shepherd's Run solar power plant project.

These facilities were to consist of stacks of lithium-ion batteries on racks inside 53-foot-long shipping containers, which were to be mounted on concrete pads and placed along the north side of Route 23, just east of the NYSEG substation in Craryville.

In the same announcement, Hecate said it was reducing the size of the project's footprint from 500 to 360 acres, of which 280 would site approximately 200,000 solar panels. Hecate claimed that it was taking these two actions because "we are listening to (local residents') views and opinions, and...we value working with the community to site and develop the best possible project."

Complying with Copake's laws — respecting Home Rule — is the only way Hecate can demonstrate that it really is listening to, and respecting, our views. This would mean limiting its facilities to 10 acres on each parcel for which it has entered into option-to-lease agreements with at least four landowners. In addition, if it could demonstrate that it could effectively shield a larger facility from view of nearby homes, Hecate could apply for a variance from the town's Zoning Board. Furthermore, seeking site approval from Copake could enable Hecate to begin construction, and then operations, substantially sooner than will be possible if it sticks with the State Siting Board (Article 10) site approval process.

Copake is officially on record as supporting renewable energy. We are doing the things that a "Climate Smart" community should do to address the existential threat of climate change, including, most recently, supporting the Conservation Advisory Committee's successful application for a Local Champions grant. We continue to urge Hecate to work collaboratively with us. Copake will continue to embrace the opportunity to do its fair share to reduce fossil fuel emissions and help New York State achieve its laudable clean energy goals. Our quarrel is with the extraordinarily disproportionate share of the load Copake is being asked to shoulder through Hecate and by New York State through its legislation.

Here are some other developments:

Several residents near the proposed site have reported receiving letters from TRC, a company working for Hecate. The letter, which TRC writes is being sent at the request of the State Department of Public Service, asks the recipients to complete a "private water well survey questionnaire." Copake's solar attorney advises that everyone should complete and submit the survey on time, because the information can be used to help determine the potential impact of the proposed Shepherd's Run power plant on local water supplies.

The Article 10 Stipulations process is drawing to a close, with formal comments by Friday, Feb. 12. Copake's solar attorney and environmental engineering firm have reviewed Hecate's proposals regarding studies it intends to undertake to satisfy the law's requirements that Hecate provide sufficient information, so the Siting Board can determine the likely environmental impacts of Shepherd's Run. The Town Board authorized Copake's representatives to submit written comments to the Siting Board. We will soon be meeting with our solar attorney to receive his advice as to whether Copake should agree to any of the proposed Stipulations.

Another Stipulations-related development: on Tuesday, Feb. 9, the State Department of Environmental Conservation (DEC) signed off on Hecate's Stipulations. This means that before approving the Stipulations, DEC isn't bothering to review, much less consider, public commentary that is submitted before the end-date for comments, including Copake's. This is particularly troubling inasmuch as the DEC Commissioner is one of the five permanent gubernatorial appointees to the State Siting Board — the board that will determine whether to grant Hecate a permit to site Shepherd's Run in Craryville.

There is another potentially very problematic development involving the state. As you know, Hecate is currently seeking site approval for Shepherd's Run from the State Siting Board, under the procedures in Article 10 of the Public Service Law. The Article 10 process is exempted from SEQRA, the State Environmental Quality Review Act, so Article 10 instead requires the Siting Board to make express findings and determinations regarding the environmental impacts of a proposed solar power plant. However, as I've been reporting, Hecate may, at some point, choose to abandon Article 10, and instead move to a more streamlined process, that of Section 94-c of the State Executive Law, by which it would seek siting approval from the newly-created Office of Renewable Energy Siting ("ORES"). As currently written, 94-c does not require ORES to make express findings and determinations regarding the environmental impacts. That's because the 94-c procedures are not exempted from a SEQRA environmental review.

The proposed 2022 State budget seeks to "fix" that. It would exempt 94-c from a SEQRA review. Should this proposal become law, ORES could issue permits to industrial-size solar power plants without making any findings and determinations about a particular project's impacts on the environment. For this reason, the Town Board passed a Resolution insisting that ORES continue to be required to conduct a full SEQRA review of any renewable energy project seeking site approval or, failing that, that Section 94-c be modified to require ORES to make specific findings and determinations regarding the environmental impacts of any project seeking ORES site approval.

Copake Applies for Water Study Grant

At the recommendation of Copake's Hamlet Revitalization Task Force, the Conservation Advisory Committee, and the Economic Development Advisory Committee, the town has



applied for a New York State grant to study water supply conditions in the hamlet. If awarded the grant, the town will use it to conduct an engineering study to evaluate current water quality in Copake Hamlet, analyze ways to minimize contamination, and review how best to protect water quality in the future. The study will also evaluate storm water runoff and flooding impacts on the water supply. The study will likely take place sometime in 2022, depending on the timing of New York State's grant review and approval process.

Calling All Dog Owners

Kyle Miller is the new local Dog Control Officer for Copake, and he has an important message for all dogs and dog owners to start off the New Year.

This new year means getting used to writing "2021", hanging up a new calendar, and writing down all the important dates on the calendar, including when to relicense your dog! Did you know that New York State requires that you license your dog in the town where you reside once your dog reaches the age of four months? This license is good for one year and could make a difference in being reunited with your pet if it were to run away. All you need is the completed license application, proof of an up-to-date rabies vaccination (unless otherwise stated by your veterinarian), and \$7 (for spayed/neutered dogs) or \$13(for un-spayed/un-neutered dogs). Upon submission, the owner will be provided with a numbered license tag for the dog that MUST be affixed to the dog's collar, which must remain on the dog at all times. Copake History

Copake's 1891 Election

The flyer in this posting was used for Copakes's 1891 election for town government positions. Benjamin Harrison, a Republican, was president of the United States.

Note the obvious change in popular names. With all due respect for any Delberts or Elvons who are around, they are now uncommon names. Also, we can see that some families are still represented in the Copake area, i.e. Silvernails, Roberts, Lampmans, and Shattucks. A few others are probably, too. The flyer also shows a few positions that no longer exist in the town: no Constables, no Overseer of the Poor, no Excise Commissioners, and no Game Constable. The last position is a state one now. I believe we also don't have elected Inspectors of Elections.


Delbert Dinehardt (in the photo) was the brother-in-law of West Copake's wealthy Henry Astor through Astor's marriage to Delbert's sister, Malvina. In the late 19th and early 20th

centuries, Delbert (with a little help from Henry who was John Jacob Astor's grandson) owned Empire Farm. He sold it later in life and moved to a large house in Hudson - which today is a dentist's office. The Ackley family later bought his farm.


