Call to Order

Supervisor Mettler calls the November 10, 2022 Town Board meeting to order and welcomes everyone. Supervisor Mettler welcomes the Meenagh family to this special evening.

Supervisor Mettler calls on Sergeant Major Flaherty to ask the Cub, Boy, and Girl Scout Troop's to come in to the meeting room.

Supervisor Mettler welcomes everyone again to the November meeting. This meeting is being conducted in person but remote access has been posted. This meeting is being recorded and the video conference will be posted on the town website within five business days.

Proclamation in Honor of Eugene F. Meenagh

PROCLAMATION

Whereas, Eugene F. Meenagh, the son of Eugene F. Meenagh and Catherine Meenagh, was born in New York City on October 4, 1922, grew up in the Bronx and graduated from Mount Saint Michaels High School, and

Whereas, upon graduation from high school in 1940, he was accepted into Fordham University but postponed his college career due to World War II, and

Whereas, in 1942, at Mitchel Field Hempstead, L.I. Eugene Meenagh enlisted in the Army Air Corps, and was deployed to the China-Burma-India Theater of Operations where he served as an aircraft mechanic working on C-47s cargo planes, and

Whereas, Corporal Meenagh and his family paid the ultimate price of war when he lost his brother, 1st Lieutenant William F. Meenagh, a B-17E Navigator who was classified as Missing-In-Action after a bombing mission in the Pacific Theater on September 17, 1942 and is memorialized at the Manila American Cemetery in the Philippines and

Whereas, after World War II, Corporal Meenagh returned to New York City where he attended Fordham University on the GI Bill and earned a Bachelor of Science Degree in Chemistry, and

Whereas, in 1948 Eugene Meenagh was accepted into the New York Police Department and served his beloved city as one of their Finest for 38 years, rising to the rank of Detective Lieutenant, and

Whereas, upon retirement from the NYPD in 1985, Eugene Meenagh became a permanent resident of Copake, and was elected Copake Town Justice and served two terms in the 1990s, and

Whereas, Eugene Meenagh was married to the former Mary Catherine King until her death in 1999 and together they have seven children, nine grandchildren, thirteen great-grandchildren, and three great-grandchildren,

NOW THEREFORE, we the Members of the Copake Town Board do hereby express gratitude to **EUGENE F.MEENAGH**, a member of the Greatest Generation, for a life of patriotism and community involvement, and on behalf of the Town of Copake, congratulate him on the celebration of his 100th birthday and **do hereby proclaim Veterans Day, Friday November 11, 2022 as EUGENE F. MEENAGH DAY in the Town of Copake.**

Supervisor's Report

An update for our last meeting.

At our last meeting I reported that at the October Board of Supervisors meeting I had spoken against and voted against a resolution to eliminate \$1 tags for garbage. With the elimination of the \$1 tag, the cheapest tag would be \$3 which could be used for a bag up to 30 gallons.

It is true that Columbia County has been losing a large amount of money on Solid Waste. This "hemorrhaging" has been attributed to the people who toss in garbage without any tags, or toss is big bags with only a \$1 tag.

Before the full board I argued that eliminating the \$1 tag would only penalize the people who were obeying the rules and that it would not resolve the cheating which would continue. Several supervisors joined me in voting no, and one or two abstained-but the Resolution passed.

But, I can now report, the Solid Waste Department has reversed their policy. At the Public Works Committee on October 25, 2022, Department Head Jolene Race reported that they able to buy 7 gallon bags to be sold for \$1.00. A Resolution in favor of that passed in Committee and was adopted by the full board last night.

If you still have \$1 tags you can use them while they last- and those are for bags up to 13 gallons. Starting in the near future however, 7 gallon bags will be available for \$1.00. This is a smaller bag than the tag allowed. On the other hand you do not have to buy plastic bags at the supermarket.

This is not the end of the discussion. Recycling and disposal of garbage is expensive for the County and has gotten more expensive. So I do not know where this will all end. But for the time being- you can buy a \$1 bag.

Solar Report November 2022-Councilperson Wolf

We find ourselves waiting for the next shoes to drop.

First, we expect that Hecate Energy Columbia County will soon be filing its third siting application submission to the NYS Office of Renewable Energy Siting ("ORES"). As I reported last month, ORES issued to Hecate a second "Notice of Incomplete Application," meaning that Hecate had not provided sufficient, detailed information in its Shepherd's Run application to enable ORES to conclude that Hecate's siting permit application was "complete".

Second, together with our co-petitioners, we are awaiting a response from New York State to our appeal in the pending lawsuit in which we are challenging the process that resulted in the regulations under which ORES operates, and the substance of the regulations themselves. The State requested an extension of time to respond, and we now anticipate that our appeal will be argued sometime in early 2023 before a panel of judges from the Appellate Division, Third Department in Albany.

Regarding the first "shoe" (Hecate's application): Interestingly, one of the areas ORES pointed to as lacking meaningful information has to do with Hecate's claimed desire to be a "community partner" with the Town. In response to the first Notice of Incomplete Application, Hecate claimed it had made significant changes to its initial siting application in response to recommendations from the *ad hoc*

Working Group. In response, ORES has told Hecate to "specifically identify and reference the Working Group's recommendations" that it has incorporated into its application.

Hecate's response should reveal to ORES what we already know: Hecate has added the "low-hanging fruit" to its application, such as agreeing to use wildlife-friendly fencing, rather than chain-link (a request initially made by this Town Board). What Hecate has been unwilling to include in its application are Working Group proposed changes that would make real differences in the Shepherd's Run proposal and its impact on nearby homeowners, but which would require Hecate to invest more money in the project: (1) creation of a 300-acre community accessible green space that would protect view sheds, provide effective screening of much of the utility-scale facility from nearby homes, even as it offers nature walks and bicycling trails to Copake residents and visitors; and, (2) Hecate remains unwilling to provide financial compensation to homeowners whose properties would be most directly and adversely affected by Shepherd's Run.

Regarding the second "shoe" (the lawsuit): Some quick background: In August, this Board voted unanimously to approve the Taghkanic Headwaters Conservation Plan, which, among other things, calls for measures to protect clean water. Last month, we passed a resolution calling on ORES to continue to deem Hecate's application incomplete unless and until Hecate provides evidence that the construction and operation of Shepherd's Run "will not negatively impact the Taghkanic Creek Watershed or water quality"...in Columbia County. Underscoring the importance of this issue, Supervisor Mettler sent a similar draft resolution to the City of Hudson, to Hillsdale, Taghkanic and Claverack, and to the County Board of Supervisors for their consideration and hopefully, for adoption.

How ORES is handling this issue provides an example of why we are challenging the ORES regulations. On October 25th, Copake's solar attorney sent a letter to ORES presenting information "essential to ORES' review" of Hecate's siting application. The letter provided ORES with a copy of the Taghkanic Headwaters Conservation Plan ("Plan"), which was created by the Columbia Land Conservancy, working with community volunteers, and adopted by this Town Board. The Plan contains important information about the Taghkanic Creek and watershed areas within the proposed site of Shepherd's Run, and our attorney, Ben Wisniewski pointed to elements of the siting application for which the Plan's information is very relevant and should evaluated by ORES as it considers the "completeness" of Hecate's application. But here's the problem: ORES has failed to post the letter (and the Plan) as a "filed document", which would make it part of the case record that ORES must review. It hasn't even filed it with the public comments on the State's Shepherd's Run webpage. Publicly, at least, the letter and the Plan seem to have disappeared.

As our attorney wrote to ORES, "Copake understands that ORES regulations do not provide for Copake's formal participation in the application scoping and completeness phase of an ORES proceeding...But Copake is also barred from challenging the sufficiency of an application after ORES deems it complete...Taken together, [this] means there is no formal process by which local government can force ORES to account for shortcomings in the scope of an application, or submit evidence of impacts that have not been identified by an applicant or ORES prior to ORES' issuance of a draft siting permit." Mr. Wisniewski concluded, "Continued exclusion of local input during the application scoping and completeness phase of ORES proceedings is not in the public interest, and is likely to result in adverse impacts to local communities."

In other words, by design, ORES' regulations — written by an industry consultant which has Hecate as a client — prevent Copake from having any input whatsoever into the early, crucial phases of ORES'

consideration of Hecate's siting application. This is one of the critical reasons why Copake and other upstate, rural towns and public-interest non-profits are asking the Court to declare invalid the regulations promulgation process and the regs themselves.

And it is why later this evening we will pass a Resolution supporting Senate Bill S9546, which would repeal 94-c of the Executive Law, eliminate ORES and its regulations, and return the siting process to Public Service Law Article 10's Siting Board. The latter, unlike ORES, would be required to make express findings regarding the environmental impacts of Shepherd's Run. And the Siting Board process, unlike ORES, would allow Copake to oppose Hecate's planned waivers of Copake's zoning provisions at an adjudicated hearing.

Finally, I'd like to thank the nine members of Sensible Solar for Rural New York for their strong letter of support for the Town Board's position on the Shepherd's Run proposal. We continue to believe that it is too big and poorly sited for our small, rural town. And to be clear: we are not negotiating with Hecate, nor have we authorized anyone to do so on the Board's behalf. In fact, I have not been contacted by anyone from Hecate in months.

Public Forum

Lindsey LeBrecht is one of the people from the Sensible Solar Group and they thought it was very important for everyone to hear the letter that was written:

Dear Supervisor Mettler and Councilpersons Wolf, Gansowski, Judd and Sullivan:

Sensible Solar for Rural New York (SSRNY) was formed in 2020 by residents of Copake and Columbia County to educate and give voice to our community regarding Hecate Energy's Shepherd's Run solar facility being proposed for development in rural Copake and Craryville, NY.

From the outset, SSRNY has been opposed to the scale of the project and has been concerned about the negative impacts Shepherd's Run will have on our community's farmland, wetlands, streams, wildlife, forests, viewsheds, historic resources, property values, and our agriculture and tourism-dependent economy. Further, our group has, and continues to, support the Copake Town Board in its opposition and litigation to the NYS 94 (C) permitting process.

In addition to our many initial concerns about Shepherd's Run, we recently disseminated information regarding negative impacts of the project on certain of Copake's cultural resources not considered by Hecate in their application. Further, SSRNY members raised another important issue, also not considered, discussed, or addressed by Hecate in their application: potential impacts of the project on the Taghkanic Creek which supplies drinking water for the City of Hudson and other residents of

Columbia County. Given the recently completed Taghkanic Headwaters Conservation Plan which calls for caring for the Taghkanic Watershed and protecting clean water, our concerns about the negative impacts of Shepherd's Run have increased.

In the eight months since Hecate first submitted their application, we understand there has been no sincere, consistent effort by Hecate with the Town of Copake to acknowledge and understand these and other concerns raised or any of the substantive recommendations put forward by the Copake Solar Working Group. In fact, there have been no substantive changes to their plan in either their March 2022 application filing or their July 2022 amended application. A second Notice of Incomplete Application was filed by ORES in September 2022 and we await Hecate's revised application to review.

At this time, we would like to reiterate SSRNY's full support for the Town of Copake's position on this project. We would a(so like to clarify that SSRNY has not and will not be a party nor have we been asked to be party to any negotiations with Hecate. Further, SSRNY believes that no organization or individual should be negotiating a Host Community Benefit Agreement with Hecate, as only Copake Town officials have standing to do so.

We support the Copake Town Board and trust they will make the best decisions for the citizens of our community.

New Business

a. Local Law to Amend the Copake Zoning Code in Relation to Cannabis Retail Businesses-Supervisor Mettler

Supervisor Mettler states that she spoke with Ken Dow about the fact that the Local Law to Amend the Copake Zoning Code in Relation to Cannabis Retail Businesses is on the Agenda. This has now been reviewed by the Columbia County Planning Board. The Town Board postponed this last month but which we have now received.

Ken Dow states that Part 1 of the SEQRA forms has already been completed and at this time completes Parts 2 and 3 with the Town Board.

Councilperson Gansowski expresses that he is not for this in any way in the Town of Copake and once you bring it in it will change the town.

A brief conversation ensued.

A motion was made by Supervisor Mettler and seconded by Councilperson Wolf to issue a negative declaration on the SEQRA portion of the above mentioned Local Law.

b. Engineer Proposal for Energy Audit of Town Hall and Park Building-Melanie Stachowiak, PE LEED AP BD+C, CMVP, M/E Engineering

Supervisor Mettler mentions that to recap, the Town Board has reached a consensus that before we spend any money to replace an air conditioner condenser- or to repair the faulty distribution of air which leaves some offices ice cold in the summer, we should have an engineer to take a look at the Town Hall to see what other repairs or upgrades should be made to both be more energy efficient, save money, and anticipate repairs before they become emergencies. The Town Board did receive a proposal from GPI but the firm they were using for the NYSERDA audit did not meet our expectations at the October meeting. GPI told us that they understood if we went to another firm. We received a recommendation from Vanessa Bertozzi who is working with Dan Haas on the local Champions program. Ms. Bertozzi is on the Village Board in Rhinebeck and that is how she got the name of M/E Engineering. M/E Engineering is a statewide firm. They have submitted a scope of work which demonstrates a much clearer understanding of the audit process. They have submitted a fifty page Flex/Tech study that she will distribute to the Town Board. Supervisor Mettler recommends to the Town Board that we enter into this agreement.

Attorney Tingley recommends to the Town Board to authorize the Supervisor to negotiate and execute the engagement letter.

A motion was made by Councilperson Gansowski and seconded by Councilperson Judd to authorize the Supervisor to negotiate and execute the engagement letter with M/E Engineering.

All in favor. Motion approved.

c. Chargeback Agreement-Community Rescue Squad

A motion was made by Councilperson Wolf and seconded by Councilperson Sullivan to authorize the Supervisor to execute the Chargeback Agreement to authorize the County to collect \$219,319 in taxes to be paid to the Community Rescue Squad.

All in favor. Motion approved.

d. Procurement Policy-Introduction of Local Law

Attorney Tingley gives a recap and advises the Town Board on the next steps which is to introduce the Local Law and to schedule a Public Hearing.

Supervisor Mettler introduces Introductory Local Law Number 3 of 2022, a local law to provide for adoption of procurement policies and procedures by Resolution. A Public Hearing will be set for 6:50pm on December 8, 2022.

Supervisor Mettler states that the Town Board has received Resolution Number 36 of November 10, 2022 To Adopt Procurement Policies and Procedures by Resolution and to Amend the Town of Copake Policy Manual and the Town of Copake's Policies and Procedures.

It is hereby **RESOLVED**, that the Town Board of the Town of Copake hereby adopts the "Town of Copake Procurement Policies and Procedures" annexed hereto, which shall take effect upon the effective date of Introductory Local Law No. 3 of 2022 (or such other or similar local law providing for adoption of procurement policies and procedures by Town Board resolution), if enacted; and

It is hereby further **RESOLVED**, that the Town Board hereby amends the Town of Copake Policy Manual as follows:

1. Upon the effective date of Introductory Local Law No. 3 of 2022 (or such other or similar local law providing for adoption of procurement policies and procedures by Town Board resolution), if enacted, Section VII, Paragraph A is thereupon amended to read in its entirety as follows:

"A. Procurement

Procurement of goods and services will be done in conformity with applicable New York State Law and the Town of Copake Procurement Policies and Procedures, as amended from time to time, a copy of which is included in the Appendices.

 Upon the effective date of Introductory Local Law No. 3 of 2022 (or such other or similar local law providing for adoption of procurement policies and procedures by Town Board resolution), if enacted, a new Appendix M is thereupon added to consist of a complete copy of the Town of Copake Procurement Policies and Procedures, as adopted herein and as may be amended from time to time.

Supporting Senate Bill S9546 which would repeal the Office of Renewable Energy Siting from state law, returning the siting of renewable energy systems to the Article X process that existed for more than a decade

WHEREAS, in 2020, Hecate Energy Columbia County 1 LLC filed pre-application papers seeking a permit from the New York State Siting Board, pursuant to Article 10 of the New York State Public Service Law, to construct the Shepherd's Run Solar Facility;

WHEREAS, the Shepherds Run Facility is to be sited within the Taghkanic Creek Watershed and on prime farmland on hundreds of acres located in the Town of Copake and Hamlet of Craryville, New York; and

WHEREAS, the Copake Town Board unanimously adopted Resolution #21, dated October 28, 2020, opposing the proposed Shepherd's Run Solar Project on the basis the project does not comply with local laws, conservation plans, and community planning objectives; and

WHEREAS, in 2020 Section 94-c of the Executive Law established a new Office of Renewable Energy Siting ("ORES") and established a streamlined siting approval process that replaces the Article 10 siting process; and

WHEREAS, Unlike the Siting Board process under Article 10 of the Public Service Law, Section 94-c and ORES regulations do not require ORES to make express findings and determinations regarding the environmental impacts of proposed projects prior to issuing a final permit; and

WHEREAS, unlike the Siting Board process under Article 10 of the Public Service Law, ORES does not provide the Town of Copake the power to oppose waiver of its local laws through an adjudicated hearing; and

WHEREAS, on May 4, 2021 Hecate Energy Columbia County elected to subject its Shepherd's Run proposal to the 94-c permitting process rather than that of Article 10, and did on March 8, 2022 file a siting permit application with the Office of Renewable Energy Siting pursuant to Section 94-c of the New York State Executive Law; and

WHEREAS, there is now pending in the New York Senate Bill S9546 which would amend the environmental conservation law, in relation to permits for major renewable energy facility sites; and repeal section 94-c of the executive law relating to the major renewable energy development program and would thus return the siting of large scale renewable energy systems to Article 10,

NOW, THEREFORE BE IT

RESOLVED that the Town Board of the Town of Copake urges the New York State Legislature to pass Senate Bill S 95465, repealing Section 94-c of the Executive Law and thus returning the approval of siting of renewable energy systems to the State Siting Board under Article 10 of the Public Service law, thus renewing the Town of Copake's power to present evidence and argument against waiver of its local laws, zoning powers, and planning objectives.

Councilperson Sullivan reports that Trunk or Treat was a huge success. The Park Commission is working on the Holiday Light Parade and at the end of the year they will be voting on appointments to the Park Commission. There are still two members needed.

Councilperson Judd reports that the Planning Board met last week and the most notable thing to mention is the major subdivision of Copake Lake going back and forth between the ZBA and Planning Board. There was a presentation on the subdivision and Councilperson Judd mentions that it looks like a very responsible project however the Planning Board hasn't seen a major subdivision in a very long time a Chairperson Haight decided that they would hire an engineer to put another set of eyes on it.

Councilperson Judd mentions that at the Conservation Advisory Committee meeting they heard about the National Resource Inventory and Councilperson Judd spoke about the progress of the electric vehicle charging stations. The Town Clerk received a call today that she gave to Councilperson Judd to follow up on.

Councilperson Wolf reports that the Short Term Rental Working Group met on October 25, 2022. The next meeting is scheduled for November 29, 2022 at which time they will complete a review of a lot of work that was done by Jay Schiff. The Short Term Working Group has scheduled a town hall meeting to get community input to find out what the community thinks of this so that the Short Term Working Group can add that into the mix of information that they already have and report back to the Town Board of any recommendations. This meeting is scheduled for Saturday, December 3, 2022 at 10:00am until 12:00pm at Town Hall. This meeting will have remote access.
