Town of Copake Public Hearing/Special Town Board Meeting Tuesday, August 22, 2023 6:00PM

This meeting is being held "in-person" in Town Hall. The access information for the meeting has been posted and there are members of the public present virtually.

Call to Order

At 6:00pm, Supervisor Mettler calls the Special Town Board Meeting of August 22, 2023 to order and opens the Special Town Board meeting with the Pledge of Allegiance.

Supervisor Mettler mentions that this meeting is open to the public for anyone in town hall or joining us online. This meeting is being recorded and will be posted online within five business days.

Supervisor Mettler states that we are now in a public meeting and there are a few items that the Town Board has to address and following that we will have the first Public Hearing.

The first item discussed is approval of the band shell bid. This has been distributed to the Town Board.

A motion was made by Councilperson Sullivan and seconded by Councilperson Wolf to accept the bid from L.D. Coon & Son Inc., dated August 7, 2023, to construct the band shell for the Copake Memorial Park for \$131,290 following two conditions; upon confirmation of the contractor has ordered the building the town will pay an \$8,000 deposit and upon completion of the foundation the town will pay \$30,000 with the balance to be owed as the balance of the work is completed.

All in favor. Motion approved.

The next item discussed is the Copake Memorial Garden Bid. This has been distributed to the Town Board.

A motion was made by Councilperson Sullivan and seconded by Councilperson Gansowski to accept the bid of Clark's Outdoor Services LLC dated August 21, 2023 to renovate the gardens at the Copake Memorial Park for the amount of \$16,870.

All in favor. Motion approved.

The next item discussed in the date for the Pickleball tournament which will be June 8, 2024 with a rain date of June 9, 2024.

A motion was made by Councilperson Wolf and seconded by Councilperson Sullivan to approve a spring date for a pickleball tournament to be sponsored by the town on June 8, 2024 with a rain date of June 9, 2024.

All in favor. Motion approved.

Next, Supervisor Mettler suggest to the Town Board to have the park building cleaned for the fall season. Supervisor Mettler has reached out to ServPro, the same company that was used last time and we were given a quote of \$1,000. This has been distributed to the Town Board.

A motion was made by Councilperson Sullivan and seconded by Councilperson Gansowski to approve the estimate from Servpro dated August 14, 2023 to clean the park building for \$1,000.

All in favor. Motion approved.

Councilperson Gansowski mentions that he noticed that the ice machine in the back is backed up with water. Supervisor Mettler states that there are several things that need to be addressed at the park building that will be included into the 2024 budget. She will speak to Bob Callahan about the ice machine that will be addressed immediately.
