Plant Manager's Report.

- The 3rd pond (Settling Pond) was sprayed on June 20 to kill the duckweed.
- June Work Weekends: July 1-2 (Chuck), July 8-9 (Randy), July 15-16 (Randy), July 22-23 (Daryl) and July 29-30 (Chuck).
- Our Phosphorus counts are down to a level that makes us incompliance of DNR requirement. Plt Manager will be testing the system by reducing the amount of Ferric going into the 1st pond. Reduce from 6 to 5.5 gals/per day.
- Mike P. reported that are Ammonia Count is the best we ever had and are well within compliance of the DNR requirement.
- Mike purchased an Eye Wash Station to be in compliance with Hazmat Standards.
 With the use of Ferric this item is needed. We will also be purchasing a fire extinguisher for the new building.
- Mike had CMAR completed the Board Member voted to except the report and assigned the Resolution Number: 2023-01
- <u>Budget Review</u>. Clerk/Treasurer Chuck Zehner presented the current 2023 Budget Report. President Kistenmacher moved to approve the current 2023 Budget Report, Vice President Kennedy seconded; motion carried and budget of dated May 31, 2023 is approved with subject to audit. Currently we spent 52% the 2023 year budget the first 5-months.
