Monthly Board Meeting Minutes
July 21, 2026, at 6:00 PM

The July town board meeting of the Town of Dexter board was called to order at 6:00 PM by Craig DeCaluwe.

Roll call – Craig DeCaluwe, Jeff Oelke, Cary Anderson, Diana Schooley and Amanda Merritt

Public Comments: No public comments.

June Meeting Minutes: Minutes were posted on the town website, at the Town Hall and at Lakeside Oasis. Board members received an email copy. Jeff requested two changes to the meeting minutes. Craig made a motion to approve the updated minutes and Jeff seconded the motion. 3 ayes. 0 nays. Motion carried.

Treasurer Report: Amanda Merritt gave the treasurer report. The previous balance was \$188,100.70. Received \$16,111.35, Paid out \$84,938.12. New balance \$119,223.93. Jeff made a motion to accept and Craig seconded the motion. 3 ayes. 0 nays. Motion carried.

Clerk Report: The Merk family was very appreciative of the flowers for Carrie's funeral and thanked the town. Public testing for election is scheduled for August 10 at 8am. WTA Membership cards are available for board members. Renewable energy conference details sent to Planning & Zoning members. Zoning conference at Pittsville Community Center being scheduled for October 13th at 5:30PM. Details will be shared with the planning and zoning members when more information becomes available. Issues with QuickBooks continue.

Permits/Licenses: No building permits for the month. Craig presented a new Special Weight Permit that the board agreed to begin using effectively. 3 ayes. 0 nays. Motion carried.

Deputy Clerk Discussion: There has been no interest in the deputy clerk position. The board discussed salary decision (\$1250/Qtr plus meeting pay of \$50/mtg). Craig made a motion to approve and Jeff seconded. Motion carried.

Roads Update: \$22,700 spent with Wood County Highway as of June 20, 2026. \$12,300 left to spend before November per our contract requirements. Jeff checked on the LSSIP program application. We are hoping to hear back by the end of the month. The application included the DNR, county figures & engineering information from the county.

Pay Bills: Bills were reviewed and read by the clerk. Craig made a motion to pay all bills. Cary seconded the motion. 3 ayes. 0 nays. Motion carried.
