RESOLUTION TO REQUEST FINANCIAL ASSISTANCE- RESOLUTION # 2017-01

WHEREAS, the Town of Dover located in Racine County, Wisconsin is seeking financial assistance and,

WHEREAS, the Town of Dover has sixty-seven tax exempt buildings within the Town's thirty-six square miles; including twenty-one Department of Veterans Affairs buildings with a value of \$55,520,561.32, thirty-eight Department of Health Services buildings with a value of \$62,535,951.49, and eight Department of Corrections buildings with a value of \$28,654,407.47. The tax and local valuation data of state-owned and operated buildings is provided by the Department of Administration's Division of Facilities Development as of January 1, 2015 and,

WHEREAS, The Town of Dover mill rate was \$2.09 in 2015, multiplied by the \$146,710,920.28 valuation of the state-owned and operated buildings would total \$306,625.82 in potential tax dollars. In 2015 the Town of Dover received a total of \$222,028.00 in State Aids and,

WHEREAS, the Town of Dover provided Emergency Medical Services to these sixty-seven tax exempt buildings in 2015 with forty-six percent or 174 total calls made to the Southern Wisconsin Center alone. The Town of Dover will continue to provide exemplary service to these tax exempt buildings.

NOW, THEREFORE, BE IT RESOLVED, that the Dover Town Board hereby requests additional financial assistance from the State of Wisconsin for calendar year 2017 and requests Senator Van Wanggaard, Assembly Speaker Robin Vos, Secretary of Veteran's Affairs Daniel Zimmerman, Secretary of the Department of Health Services (DHS) Linda Seemeyer, and Secretary of the Wisconsin Department of Corrections Jon Litscher to endorse and promote this resolution to Governor Walker.

BE IT FURTHER RESOLVED, that the Town Clerk is hereby directed to forward copies of this resolution to Senator Van Wanggaard, Assembly Speaker Robin Vos, Secretary of Veteran's Affairs Daniel Zimmerman, Secretary of the Department of Health Services (DHS) Linda Seemeyer, Secretary of the Wisconsin Department of Corrections Jon Litscher and Wisconsin Governor Scott Walker. Once the 2016 tax and local valuation data of state-owned and operated buildings is available, an updated Resolution shall be presented.
