# **Community Notification- Sex Offender Release**



### Thorin, James L. DOB 11/11/1951

In accordance with WI State Statute 301.46(2m), it has been determined that the attached information on James Thorin should be released to the community. On 01/03/2012, Mr. Thorin was committed under Chapter 980 Sexually Violent Persons Law. On 07/30/2020, the Court ordered a Supervised Release Plan be developed for Mr. Thorin. A hearing was held, and the Court approved the Supervised Release Plan. On 01/26/2021, James Thorin will be released to the community on Supervised Release. This notification is not intended to increase fear; rather, it is our belief that an informed public is a safer public.

Sex Offenders have always lived in our communities; but it was not until the WI Sex Offender Registry and Community Notification Law was enacted that law enforcement was able to share this information with the community. Citizen abuse of this information to threaten, intimidate, or harass registered sex offenders will not be tolerated.

<u>Release Date</u>: On 01/26/2021, James Thorin will be residing at 2253 170<sup>th</sup> Ave, Emerald WI.

Upon release, Mr. Thorin will be placed on Intensive Supervision, and will be subject to the Global Positioning System (GPS). Mr. Thorin will be required to register with the Wisconsin Sex Offender Registry Program for life.
