AGENDA

PLEDGE OF ALLEGIANCE: Said by all present.

APPROVAL OF AGENDA AND MINUTES FROM LAST MEETING: Motion by Bill/Phil to approve the agenda and minutes. Motion carried.

PUBLIC COMMENT: Nancy Kronstad questioned when work would be started on the Bell School Road project. Chairman Wedwick stated the work should be started at anytime soon.

ROAD REPORT: Roadman Voldberg stated the gate behind the dumpsters had been installed. He also had done some road patching. Vandervoort Logging looked at trees in the town's gravel pit to see if they would be interested in logging them off. They will get back to Vince on this. Chairman Wedwick asked that the supervisors, along with himself, to sign a land use permit concerning property Russ Thompson Excavating purchased to incorporate into their gravel pit. The permit was signed.

TREASURER'S REPORT: Balanced with Clerk.

DISCUSSION AND POSSIBLE MOTIONS:

Loga Lane Extension: Rick Romeis asked for approval to go ahead with the extension of Loga Lane. A motion was made by Bill/Phil to approve Rick Romeis go ahead with the extension project. Motion carried.

Bruno Avenue Acceptance: The Town of Flambeau has approved road but hasn't accepted it yet. The City of Ladysmith needs to approval extra territorial. Chairman Wedwick hasn't heard anything further on this.

Approval Loan for Bell School Road: A motion was made by Phil/Bill to approve borrowing \$600,000.00 from Security Financial Bank for the Bell School Road Project. Motion carried.

Approve Mowing Project: A motion was made by Bill/Phil to approve that Affordable Roadside Cutting Service cut the town's roadside ditches. Motion carried.

Approve Removal of Muskrats: A motion was made by Phil/Bill to contract with Jon Runstrom to remove muskrats on West Elm Road. Motion carried.

Culvert Replacement Update: The State has determined that two culverts in the Town of Flambeau be replaced, one on Cemetery Road and one on Rocky Ridge Road. At this time, the town will not replace them, but, wait to see if we can get funding from the State which has a program for this.

Consultant Contract for Road Goals: Chairman Wedwick presented for approval a contract with DJ Fedderly Management Consultant, LLC, for long-range town road planning. The board decided to put this on hold.

APPROVE BILLS AND SIGN CHECKS: Motion was made by Phil/Bill to pay August bills. Motion carried.
