This Special Service may be requested by a licensed physician on behalf of a patient for whom the moving of the 95-gallon wheeled garbage and recycling carts would present an unnecessary hardship or is impractical by reason of physical condition or medical problem. **Please allow a minimum of five business days for processing this exemption request.**

Town of Grafton Starts Automated Trash Garbage & Recycling collection in the Town of Grafton has switched to fully automated collection for both trash and recycling. This means that a garbage truck will pull up to the curb in front of your residence and by use of a mechanical arm system, will pick up, dump and return your cart(s) to the curb. In order to facilitate this change, a 95-gallon wheeled green trash cart, like the one in the photo to the right, was delivered to your residence along with a 95-gallon wheeled cart with yellow lid for collection of all single stream recyclable items.



Remember, single-stream recycling allows you to place all recyclable commodities, such as paper, cardboard, steel, plastic, tin, aluminum and glass, into one collection cart. Single-stream recycled items require loose placement within the collection cart.

The 95-gallon cart weighs 40 pounds when empty and is very easy to maneuver over multiple types of terrain.

In order to assist persons with disabilities who do not have anyone to help them with their chores, the Town of Grafton has contracted with Veolia to provide Walk Up Service to persons who qualify.

Qualified residents must:

- 1. Be unable to wheel their cart to the curb for collection.
- **2.** Have no one else who can assist them, such as a spouse or other live-in family member or a personal assistant.
- **3.** Be certified by a physician as needing assistance.
- **4.** Fill out and return the required request for exemption form. (Page 1)
