Local Law No. 1 of the year 2006

A local law changing the meeting of the Board of Assessment of Review of the Town of Hammond.

Be it enacted by the Town Board of the Town of Hammond as follows:

SECTION I. PURPOSE:

The State of New York has granted the governing body of the assessing unit of the Town of Hammond, which employs an assessor who is at the same time employed by another assessing unit, the power to establish a date for the meetings of the Board of Assessment Review other than that provided by State Law

SECTION II. DATE ESTABLISHED:

The Board of Assessment Review for the Town of Hammond shall meet on Wednesday following the fourth Tuesday in May each year and thereafter as may be necessary to discharge its duties.

SECTION III. EFFECTIVE DATE:

This local law shall become effective upon its filing with the Secretary of the State of New York or five (5) days after its enactment, whichever occurs later.
