PROPOSED LOCAL LAW (NO. /) FOR THE YEAR 2007 ESTABLISHING THE PROPERTY TAX EXEMPTION FOR COLD WAR VETERANS

BE IT ENACTED by the Board of Legislators of St. Lawrence County as follows:

- Section 1. In accordance with the provisions of Section 458-b of the Real property Tax Law of the State of New York, real property owned by one or more persons, each of whom is a "Cold War Veteran" as defined by New York State Real property Tax Law, Section 458-b shall be exempt from county taxation to the extent of 15% of the assessed valuation.
- Section 2. This Local Law, in every case, shall conform to State Law.
- Section 3. This local law will take effect no later than ninety days before the taxable status date next occurring on or after the thirty-first of December, two thousand seven, after a public hearing.
