A Local Law to Provide Real Property Tax Exemptions for Cold War Veterans (Insert title)

Be it enacted by the Town Board of the Town of Hammond as follows:

(Name of Legislative Body)

<u>Article 1. - Statement of Authority</u>. This Local Law is enacted, pursuant to the authority granted under Article 16 of the Town Law and Section 10 and 20 of the Municipal Home Rule Law.

Article 2. - Statement of Purpose and Findings.

This local law is intended to continue exemptions for property owners who are Cold War Veterans within the Town of Hammond as previously enacted by Local Law #1 of 2007 which established the Property Tax Exemption for Cold War Veterans, which local law expired by operation of law ten (10) years after its effective date.

<u>Article 3. – Enactment.</u> The Town Board of the Town of Hammond enacts a new Cold War Veterans Exemption pursuant to Real Property Tax Law 458-B – Cold War Veterans Exemptions as follows:

Section 1. In accordance with the provisions of Section 458-B of the Real Property Tax Law of the State of new York, real property owned by one or more persons, each of whom is a "Cold War Veteran" as defined by the New York state Real Property Tax law, Section 458-B shall be exempt from County taxation to the extent of 15% of the assessed valuation without regard to any time limitation.

<u>Section 2.</u> This Local Law, in every case, shall conform to New York State law.

<u>Article 4. Severability.</u> If any part of this local law shall be found to be void, voidable, or unenforceable for any reason whatsoever, it shall not affect the validity or enforceability of any remaining section or provision of this local law.

Article 5. Effective Date. This Local Law will take effect no later than ninety (90) days before the taxable status date next occurring on or after the thirty-first (31st) of December, two thousand nineteen (2019) after public hearing.
