PERMITS REQUIRED:

All new one and two family, and all new multifamily dwellings

All residential building additions or remodels/alterations valued at \$1,000 or greater

All residential decks and/or porches

All residential accessory structures larger than 250 sq. ft.

All new commercial/industrial projects

All commercial/industrial building additions/remodels

All electrical services: including new and upgrades

- All commercial/industrial projects (including additions and remodels) building permit fee \$7 per \$1000 total project value (min. \$150)
- 2. All new one and two-family homes building permit fee
