<u>Approve EMS Provider for 2024</u> – Motion by Zaspel to approve contribution in the amount of \$5239.50 (population 499 x \$10.50 per capita) to the Cumberland Healthcare Ambulance Fund to provide EMS and Ambulance services for the Town of Johnstown for 2024. Seconded by Lowe. Motion Carried.

Road Maintenance Report – Sanding and seasonal snow removal will continue as needed.
