ORDINANCE NO. 7
AN ORDINANCE PROVIDING FOR WEIGHT LIMITS ON CERTAIN TOWN
ROADS.
The Town Board of the Town of Knowlton, do ordain as follows:

## SECTION 1 - SPECIAL OR SEASONAL WEIGHT LIMITS

The Town Board of the Town of Knowiton shall have the authority to impose special or seasonal weight limits to prevent injury to the roadway of any highway, bridge, or culvert within the jurisdiction of the Town of Knowlton, or for the safety of users of such roadway, highway, bridge, or culvert and the said Town Board shall be responsible for erecting signs giving notice thereof in accordance with Section 349.16 of the Wisconsin Statutes.

## SECTION 2 - PERMANENT WEIGHT. LIMITATIONS

Permanent weight limitations shall be imposed upon the following roadways in the Town of Knowlton:
(1) Designation as "Class B Highways" -

The Town of Knowlton hereby designates the following town highways as "Class B Highways" as that term is defined in Section 348.16(1)(b) of the. Wisconsin Statutes:
(a) Old Highwaly 51 from South Road on the North to Highway 34 on the South.
(2) Permanent weight restrictions

The gross weight imposed on the following highways by all axles of a vehicle or combination of vehicles shall not exceed:
(a) Seven (7) tons on Locker Road from Balsam Road to County Highway X. (see amendments)
(b) Seven (7) tons on Rozak Road and Sandy Creek Road from County Trunk C to Ashley Road.
(c) Three (3) tons on that portion of Knowlton Road from Highway 34 on the West of County Highway DB on the East. (see amendments)

SECTION 3 OFFICIAL 'TRAFFIC SIGNS AND SIGNALS

The road foreman or other person authorized by the Town Board of the Town of Knowlton, is hereby authorized and directed to procure, erect, and maintain appropriate standard traffic signs, signals, and markings conforming to the rules and standards of the State of Wisconsin Department of Transportation, Division of Highways, giving such notice of the provisions of this ordinance as required by State law. Signs shall be erected in such locations and manner as the Town Board of the Town of Knowlton shall determine will best effect the purposes of this ordinance and give adequate warning to the users of the highways and roadways in the town.

## SECTION 4 - CONFLICTING ORDINANCES REPEALED

All ordinances or parts of ordinances in conflict herewith are hereby repealed.
SECTION 5 -EFFECTIVE DATE
This ordinance shall be in full force and effect from and after its passage and publication as provided by law.
