ORDINANCE NO. 01-2000-001
AN ORDINANCE TO ESTABLISH LICENSE & PERMIT FEES
WHEREAS the Town Board authorizes and grants permission for various matters; and it is better public policy for the person or association seeking permission to defray the costs associated with such permission;  NOW, THEREFORE, the Town Board of LaGrange ordains as follows:
SECTION 1. FEES ESTABLISHED
Fees shall be charged for the following permits and/or activities:
A (1) Condition use permit;
(2)Rezoning;
(3)Variance;
(4)Certified survey map;
(5)Subdivision plat;
(6)Class A alcohol beverage licenses;

(7)Class B alcohol beverage licenses;
(8)Class C wine license;
(9)Picnic license;
(10)Dog license; and
(11)Kennel license.
B. (1) Driveway culvert permits;
(2)Fire number/address;
(3)Building, plumbing and electrical permits;
(4)Right of way permits; and
(5)Pier permits.
SECTION 2. AMOUNT OF FEE
The amount of the fee for each permit shall be established by the Town Board by motion made and passed, and may be amended from time to time by motion made and passed.

### **SECTION 3. PROCEDURE**

All fees and charges shall be paid to the Town of LaGrange. Fees for those permits or activities listed in Section 1.A. of this ordinance shall be remitted to the Town Treasurer prior to the permit being granted or the activity taking place. The Treasurer shall issue a receipt.

### SECTION 4. PENALTY AND COMPLIANCE

A. No permit or license shall be issued for the permits or activities listed in Section 1.A. of this ordinance until and unless the applicant has paid all money owed to the Town of LaGrange including,

but not limited to, unpaid forfeitures, taxes or fees, except if the debt is subject to a pending court case or appeal, and except dog licenses which shall not be withheld for unpaid forfeitures pursuant to §66.117, Stats.

B. No person, firm or association shall engage in or conduct the event or activity subject to a fee as established by this ordinance without payment of the fee and issuance of any permit or approval required by law. Any person, firm or association engaging in such activity or event without timely payment of the fee and issuance of any permit or approval required by law shall pay a late fee of double the permit fee, in addition to any penalties authorized by law. The Town Board may relieve the applicant from a double permit fee for hardship, not created by the applicant.

#### **SECTION 5. REPEAL AND SEVERABILITY**

This ordinance repeals any prior ordinance which is irreconcilably inconsistent with this ordinance, however, only those parts of the ordinance which are inconsistent with this ordinance. The Town Board intends all parts of this ordinance to be severable from all other parts, in the event that a court declares part of this ordinance to be invalid.
