1-6-1 WARD BOUNDARIES:

- (1) That the Town of Lake Mills, Jefferson County, Wisconsin be and hereby is divided into three wards which shall be designated as Ward Number 1, Ward Number 2 and Ward Number 3. See Exhibit #1 dated October 8, 2021 attached to the ordinance.
- (2) That Ward Number 1 shall include the following sections as are located in the Town of Lake Mills, Jefferson County, Wisconsin: Section 1 (south 1/3 of section), Sections 2 and 3 (small area south of county highway B), Section 9 (area south of county highway B and east of county highway S), Section 10 (area east of county highway S), all of Sections 11, 12, 14 and 15, Section 16 (area east of county highway S), all of Section 22, Section 23 (area north of county highway A), Section 26 (small area north of county highway A) and Section 27 (area north of county highway A and east of county highway S) Township 7 North, Range 13 East, Town of Lake Mills, Jefferson County, Wisconsin.
- (3) That Ward Number 2 shall include the following sections as are located in the Town of Lake Mills, Jefferson County, Wisconsin: Section 1 (north 2/3 of section), Sections 2 and 3 (excluding small areas south of county highway B), all of Sections 4, 5 and 6, Sections 7, 8, 9 and 10 (areas north of county highway B). Township 7 North, Range 13 East, Town of Lake Mills, Jefferson County, Wisconsin.
- (4) That Ward Number 3 shall include the following sections as are located in the Town of Lake Mills, Jefferson County, Wisconsin: Section 7 (small area south of county highway B), Section 8 (area south of county highway B), Section 9 (area south of county highway B and west of county highway S), Section 16 (area west of county highway S), all of Sections 17, 18, 19, 20 and 21, Section 23 (area south and east of county highway A), Sections 24, 25 and 26 (excluding small areas north of county highway A), Section 27 (area south of county highway A and west of county highway S), all of Sections 28, 29, 30, 31. 32, 33, 34. 35 and 36. Township 7 North, Range 13 East, Town of Lake Mills, Jefferson County, Wisconsin.
- (5) That the elected officials shall be selected by the voters at large without regard to Ward. Elected officials shall be selected from the Town of Lake Mills as a whole and shall not be selected in regard to Ward.
- (6) These Ward Boundaries were created in December of 2021. Pursuant to the 2020 census and based on population the Town of Lake Mills went from two wards to three wards.

1-6-2: SEVERABILITY:

- (1) The provisions of this Ordinance shall be deemed severable. It is expressly declared that the Town Board would have passed the other provisions of this Ordinance irrespective of whether or not one or more provisions may be declared invalid. If any provision of this

Ordinance is held invalid, the remainder of the Ordinance and the application of such provisions to other persons or circumstances shall not be affected thereby.

1-6-3 EFFECTIVE DATE:

This Ordinance shall go into effect upon passage and publication on June 13, 1995
