

CHAPTER 4

LICENSES FOR SODA WATER BEVERAGES CIGARETTES AND AUCTION

2-4-1: PURPOSE: The Town Board of Supervisors of the Town of Lake Mills, Jefferson County, Wisconsin finds that it is in the best interest of the public to regulate the sale of soda water beverages, cigarettes, and to require a license for auctions held in the Town of Lake Mills.

2-4-2: LICENSE REQUIREMENTS AND RESTRICTIONS:

(1) APPLICATION PROCEDURE. All applications for licenses under this chapter shall be made in writing on forms prescribed by the Town Clerk. All applications shall be filed with the Town Clerk. At the time of filing, the applicant shall pay the Town Clerk the annual fee (See Town of Lake Mills Fee, Bonds and Deposits Schedule) for the following licenses

- (a) SODA WATER LICENSE
- (b) LICENSE TO SELL CIGARETTES:
- (c) LICENSE TO HOLD AUCTION

(2) No person shall sell soda water beverages, cigarettes, or hold an auction in the Town of Lake Mills without first obtaining a permit to do so.

2-4-3: REVOCATION AND SUSPENSION OF LICENSES: A license issued under this ordinance may be suspended or revoked by the Town Board in the event that the licensee is convicted of an offense in any Court of record for a violation in the use of a permit. If there is a Court Order enjoining the holding of an auction, the license to hold said auction shall automatically be suspended.

2-4-4: SEVERABILITY- The provisions of this Ordinance shall be deemed severable. It is expressly declared that the Town Board would have passed the other provisions of this Ordinance irrespective of whether or not one or more provisions may be declared invalid. If any provision of this Ordinance is held invalid, the remainder of the Ordinance and the

application of such provisions to other persons or circumstances shall not be affected thereby.

2-4-5: EFFECTIVE DATE- This Ordinance shall go into effect upon passage and publication on June 13, 1995
