## All-Terrain Vehicle & Utility Terrain Vehicle Route Ordinance

STATE OF WISCONSIN

Town of Lincoln

Polk County

#### SECTION I - TITLE AND PURPOSE

The title of this ordinance is the Town of Lincoln All-Terrain Vehicle & Utility Terrain Vehicle Route Ordinance. The purpose of this ordinance is to establish all-terrain vehicle & utility terrain vehicle routes in the town and to regulate the operation of all-terrain vehicles & utility terrain vehicles in the town.

#### **SECTION II - AUTHORITY**

The Town Board of the Town of Lincoln, Polk County, Wisconsin, has the specific authority to adopt this All-Terrain Vehicle & Utility Terrain Vehicle Route Ordinance under <u>s. 23.33 (8) (b)</u> and <u>(11)</u>, Wis. stats.

#### SECTION III - ADOPTION OF ORDINANCE

The Town Board of the Town of Lincoln, Polk County, Wisconsin, by this ordinance, adopted on proper notice with a quorum and roll call vote by a majority of the town board present and voting, provides the authority for the town to designate all-terrain vehicle & utility terrain vehicle routes in the town and to regulate the use of those routes and all-terrain vehicles & utility terrain vehicles in the town.

# SECTION IV - OPERATION OF ALL-TERRAIN VEHICLES & UTILITY TERRAIN VEHICLES

Pursuant to <u>s. 23.33 (4) (d) 4.</u>, Wis. stats., except as otherwise provided in <u>s. 23.33 (4)</u>, Wis. stats., no person may operate an all-terrain vehicle or utility terrain vehicle on the roadway portion of any highway in the town except on roadways that are designated as all-terrain vehicle & utility terrain vehicle routes by this ordinance. Operation of all-terrain vehicles & utility terrain vehicles on a roadway in the town that is an all-terrain vehicle & utility terrain vehicle route is authorized only for the extreme right side of the roadway except that left turns may be made from any part of the roadway that is safe given prevailing conditions.

# SECTION V - DESIGNATION OF ALL-TERRAIN VEHICLE & UTILITY TERRAIN VEHICLE ROUTES

All Town roads are designated all-terrain vehicle & utility terrain vehicle routes in the Town of Lincoln.

# SECTION VI - CONDITIONS APPLICABLE TO ALL-TERRAIN VEHICLE & UTILITY TERRAIN VEHICLE ROUTES

Pursuant to <u>s. 23.33 (8) (d)</u>, Wis. stats., the following restrictions are placed on the use of the town all-terrain vehicle & utility terrain vehicle routes designated by this resolution:

- A. Routes shall be marked with uniform all-terrain vehicle & utility terrain vehicle route signs in accordance with <u>s. NR 64.12 (7)</u>, Wisconsin Administrative Code. No person may do any of the following in regard to signs marking town all-terrain vehicle & utility terrain vehicle routes:
- 1. Intentionally remove, damage, deface, move, or obstruct any uniform all-terrain vehicle & utility terrain vehicle route or trail sign or standard or intentionally interfere with the effective operation of any uniform all-terrain vehicle & utility terrain vehicle route or trail sign or standards if the sign or standard is legally placed by the state, any municipality or any authorized individual.
- 2. Possess any uniform all-terrain vehicle & utility terrain vehicle route or trail sign or standard of the type established by the department for the warning, instruction or information of the public, unless he or she obtained the uniform all-terrain vehicle & utility terrain vehicle route or trail sign or standard in a lawful manner. Possession of a uniform all-terrain vehicle & utility terrain vehicle route or trail sign or standard creates a reputable presumption of illegal possession.
- B. Operation shall be subject to all provisions of <u>s. 23.33</u>, Wis. stats., which is adopted as a part of this ordinance by reference, pursuant to <u>s. 23.33</u> (11), Wis. stats.
- C. A copy of this ordinance shall be sent by the town clerk to the Polk County Sheriff's Department.
- D. Other conditions to apply to all operators (and passengers where applicable)
  - All ATV & UTV operators shall ride single file;
  - All ATV & UTV operators shall observe 25 mile per hour speed limit;
  - All ATV & UTV operators shall slow the vehicle to 10-mph or less when operating within 150 feet of a dwelling;
  - All ATV & UTV operators shall remain on blacktopped surface.

SECTION VII - ENFORCEMENT

This ordinance may be enforced by any law enforcement officer authorized to enforce the laws of the state of Wisconsin.

#### **SECTION VIII - PENALTIES**

The penalties under in s. 23.33 (13) (a), Wis. Stats., are adopted by reference.

#### **SECTION IX - SEVERABILITY**

If any provision of this ordinance or its application to any person or circumstance is held invalid, the invalidity does not affect other provisions or applications of this ordinance that can be given effect without the invalid provision or application, and to this end, the provisions of this ordinance are severable.

#### **SECTION X - EFFECTIVE DATE**

This ordinance is effective on publication.

The town clerk shall properly publish this ordinance as required under <u>s. 60.80</u>, Wis. stats.
