Ordinance 2009-1 Town of Lynne Tripoli, WI 54564

An Ordinance Related to

ALL-TERRAIN VEHICLES

The Town of Lynne Board of Supervisors in the Town of Lynne, Oneida County Wisconsin, establishes this All-Terrain Vehicle Ordinance pursuant to Wisconsin State Statutes, Section 23.33(8) & (11) and shall replace any and all previous ordinances and amendments pertaining to All-Terrain Vehicles, hereafter referred to as 'ATVs' and Utility Terrain Vehicles (side by sides) hereafter referred to as 'UTVs'. For the purpose of this ordinance, both ATVs and UTVs are referred to and considered as ATVs hereafter.

Section 1: Purpose and Authority

The purpose of this ordinance is to establish ATV routes and regulations as to their operation and provide safe and enjoyable ATV recreation consistent with the public's rights and interests.

Section 2: ATV Routes

The following roads are designated as ATV routes within the Town of Lynne:

Willow Road from Highway 8 to the north town boundary with Town of Minocqua.

South Pier Lake Road Boyle Road Flowage Road Rapids Road Talbot Road

Thunder Creek Road Otto Bez Road

Conservation Road
Wilson Road
Forest Crop Road

Mc Cord Road North Turcott Road South Turcott Road

West Road

Lamer Springs Road Willow Falls Road Bushey Road Al Hinz Road Muskellunge Road

Work Road

Indian Village Road East Indian Village Road

Town Hall Road Depot Road Ruth Road Johnson Road Ahola Road Niemi Road Tripoli Drive

Section 3: Speed Restrictions

The maximum speed limit for ATVs shall be 25 miles per hour on all the roads listed in section 2, with the exception of South Pier Lake Road. The maximum speed limit shall be 15 miles per hour on South Pier Lake Road.

Section 4: ATV Signs

Roads designated as ATV routes shall be signed with approved ATV signs and those signs shall be placed at the beginning of all routes and at such locations and intervals as necessary to enable ATV operators to comply. The routes designated in Section 2 which has other than 25 mph speed limits shall be signed. The signage shall be the responsibility of the Town.

Section 5: Enforcement

The provisions of this ordinance can be enforced by the proper law enforcement authorities having jurisdiction including but not limited to the Oneida County Sheriffs Department, Wisconsin State Patrol and the Department of Natural Resources.
