RESOLUTION 2021 – 05 TO ADOPT WARD PLAN TO COMBINE MUNICIPAL WARDS FOR VOTING PURPOSES BASED ON 2020 CENSUS AND COUNTY SUPERVISOR DISTRICTS

WHEREAS, Wisconsin Statutes, Section 5.15 requires all cities, villages and towns with a population of 1,000 or more to establish municipal wards based on the results of the 2020 census.

WHEREAS, Section 59.03(3)(b) of the Statutes requires that each county board adopt and transmit to each municipal governing body in the county a tentative county supervisory district plan, dividing the county into districts and designating the approximate location and population of each ward proposed to effectuate the division of the county into districts.

WHEREAS, these laws require that each municipality designate by consecutive whole number, geographical description and population, the various wards to be created within the municipality. Ward 1 includes the area in the Town of Medina south of County Hwy T and State Hwy 19; Ward 2 includes the area in the Town of Medina north of County Hwy T and State Hwy 19.

NOW, THEREFORE BE IT RESOLVED that the TOWN OF MEDINA adopts the wards described on the attached map. **WARD 1** is the Town of Medina, census blocks: 550250118001046 to 550250118001047; 550250118001085 to 550250118001086; 550250118001090, 550250118002007 to 550250118002017; 550250118002023 to 550250118002027; 550250119001000, 550250119001001, 550250119002000, 550250119002001, and 550250119002009. **WARD 2** is the Town of Medina, census blocks: 550250118001028, 550250118001029, 550250118001035, 550250118001036, 550250118001037 to 550250118001045; 550250118001048 to 550250118001050; 550250118001069, 550250118001074, 550250118001075, 550250118001079, 550250118001081 to 550250118001084; 550250118001087 to 550250118001089; 550250118001091, 550250118003007 to 550250118003013; 550250118003030, 550250118003031, 550250118003042, 550250118004030 to 550250118004039; 550250118004045, 550250118004047 to 550250118004050; and 550250118004059.

BE IT FURTHER RESOLVED, Wards 1 and 2 votes at 634 State Hwy 19, Marshall, WI 53559.

BE IT FINALLY RESOLVED, that upon passage, a copy of this resolution shall be filed with the Town Clerk, who shall transmit a copy of the ward plan and this resolution to the Dane County Clerk within five days of its adoption and that this resolution shall remain in effect for each election until modified or rescinded, in accordance with Statute, or until a new division is made following the next federal decennial census.
