POWTS Special Assessment: Pursuant to Resolution Number 124-09, adopted by the Fond du Lac County Board of Supervisors on March 16, 2010, and effective on the 2013 property tax bill, Fond du Lac County will apply a special assessment fee of \$6.00 for each Private Onsite Wastewater Treatment System (POWTS) in Fond du Lac County. This annual fee is designed to cover the costs of information collection and administration of the POWTS program. If you are a tax-exempt organization (i.e. church or governmental unit), you will still receive the charge of \$6.00 per POWTS since this is a special assessment, not a tax. If you feel this information is in error, please call the Fond du Lac County Code Enforcement Office at 920-929-3139. Please leave your name, address of the property, phone number, and why you feel this assessment is in error.
