

ORDINANCE NO. 2022-24
TOWN OF MILTON
AN ORDINANCE ESTABLISHING SPEED LIMITS

An Ordinance establishing speed limits on certain roads in the Town of Milton, Buffalo County, State of Wisconsin.

WHEREAS, a Speed Limit Ordinance was adopted by the Town of Milton on August 25, 1982, a further Speed Limit Ordinance numbered 970813, was adopted August 13, 1997, and a further Speed Limit Ordinance numbered 2019-15, was adopted June 18, 2019 by the Town Board of the Town of Milton.

WHEREAS, the Board deems it expedient and necessary to modify the Speed Limit Ordinances heretofore adopted and to add further specific speed limit restrictions in the Town;

NOW THEREFORE, the Town Board of the Town of Milton does ordain as follows:

Section I: The Speed Limit Ordinance adopted August 11, 1982 is hereby rescinded.

Section II: The Speed Limit Ordinance numbered 970813, adopted August 13, 1997 is hereby rescinded.

Section III: The Speed Limit Ordinance numbered 2019-15, adopted June 18, 2019 is hereby rescinded.

Section IV: The following speed limits are established on the Town Roads, or portions thereof, indicated below, which restrictions are in addition to any speed restrictions otherwise imposed by Wis. Stat. Sec. 346.57. The limits imposed extend in both directions.

(a) No vehicle shall exceed a speed of 25 miles per hour on Indian Creek Road from the Burlington Northern Railroad Crossing extending North therefrom for one-half (.5) mile.

(b) No vehicle shall exceed a speed of 45 miles per hour on Waumandee Creek Road from the junction of State Highway 35 extending approximately 4.1 miles to the junction of Waumandee Creek Road with State Highway 88.

(c) No vehicle shall exceed a speed of 35 miles per hour on Bechly Road from the junction of State Highway 35 extending approximately one-half (.5) mile to the junction of Indian Creek Road.

(d) No vehicle shall exceed a speed of 45 miles per hour on Kamrowski Road.

(e) No vehicle shall exceed a speed a of 35 miles per hour on Lower Eagle Valley Road.


Section V: Any person violating any provision of this Ordinance shall, upon conviction, be subject to the penalty provided in Wis. Stat. Sec. 346.60, together with the costs of prosecution thereof.

This Ordinance shall take effect upon passage and posting according to law.


