SECOND SUPPLEMENTAL BOND RESOLUTION DATED JULY 11, 2023 OF THE TOWN BOARD OF THE TOWN OF OSWEGO AMENDING SECTION 4 OF BOND RESOLUTION ADOPTED ON MARCH 9, 2021, AS SUPPLEMENTED ON AUGUST 23, 2022, IN ORDER TO CORRECT THE PERIOD OF PROBABLE USEFULNESS OF THE BONDS AUTHORIZED THEREIN.

WHEREAS, on March 9, 2021 the Town Board of the Town of Oswego (the "Original Bond Resolution") authorized the planning, design, acquisition, installation and construction of a new sanitary sewer system for the Lakeshore Commercial Sewer District, including but not limited to the construction of a combination of gravity and low pressure sewer mains and appurtenances along County Route 89, Fred Haynes Boulevard and NYS Route 104 in the Town of Oswego, Oswego County, New York, including issuance costs (the "Purpose") at a maximum estimated cost of \$5,550,000, and the issuance of serial general obligation bonds (the "Bonds") in the aggregate principal amount of not to exceed \$790,000; and

WHEREAS, pursuant to a supplemental bond resolution adopted by the Town Board on August 23, 2022 (the "Supplemental Resolution"), the Town Board of the Town approved increasing the cost of the Purpose to an aggregate maximum cost of \$6,500,000; and

WHEREAS, Section 4 of the Original Bond Resolution set forth the period of probable usefulness of the Purposes as follows:

"Section 4. It is hereby determined that the Purpose is one of the class of objects or purposes described in Subdivision 4 of Paragraph a of Section 11.00 of the Local Finance Law, and that the period of probable usefulness of the Purpose is thirty (30) years. The proposed maturity of the Bonds authorized herein will be in excess of five (5) years."

WHEREAS, Subdivision 4 of Paragraph a of Section 11.00 of the Local Finance Law provides that the period of probable usefulness of the Purpose is forty (40) years;

WHEREAS, the Town Board of the Town desires to adopt this Second Supplemental Bond Resolution to amend Section 4 of the Original Bond Resolution to set forth the correct period of probable usefulness of the Purpose;

WHEREAS, the Town Board of the Town has determined that the Purpose constitutes a "Type II Action" for the purposes of the New York State Environmental Quality Review Act and the regulations thereunder; and

NOW THEREFOR, BE IT RESOLVED BY THE TOWN BOARD OF THE TOWN OF OSWEGO AS FOLLOWS:

<u>Section 1</u>. The Town Board hereby amends Section 4 of the Original Bond Resolution to read as follows:

Section 4. It is hereby determined that the Purpose is one of the class of objects or purposes described in Subdivision 4 of Paragraph a of Section 11.00 of the Local Finance Law, and that the period of probable usefulness of the Purpose is forty (40) years. The proposed maturity of the Bonds authorized herein will be in excess of five (5) years.

<u>Section 2</u>. The other terms of the Original Bond Resolution and the Supplemental Bond Resolution shall remain in full force and effect.

Section 3. This resolution shall take effect immediately upon adoption.
