RESOLUTION APPROVING BYLAWS OF THE COMMUNITY DEVELOPMENT AUTHORITY OF THE TOWN OF PHELPS, WISCONSIN; APPROVING OFFICERS; AND OTHER ORGANIZATIONAL MATTERS THERETO; AND DESIGNATING REDEVELOPMENT BOUNDARIES AND DECLARING NEED FOR REHABILITATION

WHEREAS, the Community Development Authority of the Town of Phelps, Wisconsin (the "Authority") is a Community Development Authority organized by the Town of Phelps, Wisconsin (the "Town") and is authorized by Sections 66.1333 and 66.1335 of the Wisconsin Statutes, as amended (the "Act") to prepare redevelopment plans and urban renewal plans and undertake and carry out redevelopment and urban renewal projects within the corporate limits of the Town, including but not limited to:

- to acquire property necessary or incidental to an urban renewal program and to lease, sell or otherwise transfer such property to a public body or private party for use in accordance with a redevelopment plan;
- (b) to enter into contracts determined to be necessary to effectuate the purposes of the Act; and
- (c) to issue revenue bonds to finance its activities; and

WHEREAS, a redevelopment plan ("Redevelopment Plan") is required to include property within its boundaries, as fully described on Exhibit A hereto (the "Project Area"); and

WHEREAS, the Town and the Authority have prepared a Redevelopment Plan attached hereto as Exhibit B in accordance with 66.1333(b) of the Wisconsin Statutes; and

WHEREAS, the Project Area's boundaries, as shown on the map attached hereto as Exhibit C, have been determined to be a blighted area in need of rehabilitation and blight elimination in accordance with Section 66.1333(6)(b)(1) of the Wisconsin Statutes, and

WHEREAS, the Authority will hold a public hearing on______, 2016 in accordance with Section 66.1333(6)(b)(3); and

WHEREAS, the Authority has authorized and directed the Executive Director to publish ne notice of public hearing attached hereto as Exhibit D regarding the proposed Redevelopment lan in the official newspaper of the Town on
WHEREAS, the Authority has authorized and directed the Executive Director to mail, on or efore, 2016, by certified mail with return receipt requested, the Notice ttached as Exhibit D, to each owner of the Project Area; and
WHEREAS, the Town and the Authority have found that the Redevelopment Plan is feasible and is in conformity with the master plan of the Town in accordance with Section 56.1333(6) of the Wisconsin Statutes.
NOW, THEREFORE, BE IT RESOLVED by the Town Board that:
1. <u>Findings and Determinations</u> . It has been found and determined and is hereby declared:
(a) that development in the Project Area is consistent with and in furtherance of the public purposes, plans and objectives set forth in the Redevelopment Plan; and
(b) that development would act as an inducement for further development in the Project Area, thereby making more likely the accomplishment of the public purpose objectives set forth in the Act.
2. <u>Preliminary Approval of the Redevelopment Plan</u> . The Town Board does hereby preliminarily approve the Redevelopment Plan attached hereto as <u>Exhibit B</u> , for the Project Area. Approval of the Redevelopment Plan shall not be effective until: (i) the public hearing referenced herein has been held and (ii) the Authority and the Town Board approve such Redevelopment Plan by subsequent resolution.
3. <u>Public Hearing</u> . The Authority will hold a public hearing on, 2016, in accordance with Section 66.1333(6) (b) (3) and this resolution. The Executive Director has, on behalf of the Authority and the Town, published the notice of public hearing attached hereto as <u>Exhibit D</u> in the official newspaper of the Town.
4. <u>General Authorizations</u> . The Town Chairman and the Town Clerk/Treasurer and the appropriate deputies and officials of the Town, in accordance with their assigned responsibilities are hereby each authorized to execute, deliver, publish, file and record such other documents, instruments, notices and records and to take such other actions as shall be necessary or desirable to accomplish the purposes of this resolution.
Any actions taken by the Town Chairman and the Town Clerk/Treasurer consistent with this resolution are hereby ratified and confirmed.
