ANNUAL DOG LICENSES

April 1st is the deadline that all dogs over the age of 5 months should be licensed. There is a \$10.00 late fee for each license issued after April 1st. Owners of dogs not licensed by **JULY 1st MAY BE ISSUED A CITATION.**

To license your dog:

**Send a copy of your rabies vaccination certificate showing the date the shot was given, the date next shot is due, the manufacture's name and serial number.*

**Send a check payable to the TOWN OF POYGAN.*

-Costs for dog licenses are:

\$5 for dogs that are spayed or neutered.

\$10 for dogs that are not spayed or neutered.

If you no longer have a dog, please contact Trina so that we can keep our records current. If you have questions, call Trina at (920) 582-7458.

If you are missing your dog or find a dog, please call a town board member, we do not have an Animal Control Officer. Warm weather brings abandoned pets from the cities. Residents that surrender these pets or their own to the shelters must pay the fee, only Town Officers can surrender animals at the town's expense. The town currently has a contract with the Oshkosh Area Humane Society for our stray dogs.

DOGS RUNNING AT LARGE

Per State Statute, County and Town ordinance: No person shall permit any dog to run at large in the Town at any time. Each owner of any such dog is required to confine it within the limits of their premises except when it is attended to by some person. For purposes of this section, the phrase running at large embraces all places within the Town except the owners premises, and includes all streets, alleys, sidewalks or other public or private property. Unrestrained animals may be taken and impounded in a humane manner. Citations may be issued.

LAND USE PERMITS

A Land Use Permit is required for all new structures and additions *prior* to obtaining a building permit. James Hanneman, Zoning Administrator issues the Land Use Permits and may be contacted at (262) 339-3602.



BUILDING PERMITS

Building Permits are required in the Town of Poygan. If you have a question if a permit is required, please contact Marty Johnson who issues the building permits. Some portions of the town are under County Zoning and approval may be required prior to the Town Building Permit being issued. The fee for the permit is \$50.00 plus one dollar for each thousand dollars of improvement in excess of \$20,000.00. Marty can be reached at (920) 410-6756. If he is not available, please leave a message and he will return your call and make arrangements to meet with you. *If improvements are made without a permit, fines will be issued.*

BUILDING INSPECTIONS

The Town requires UDC Inspections for all new dwellings as well as additions, decks and remodeling. Information about this process will be provided at the time the building permit is issued.

ADDRESSES

Please contact the Town Treasurer with all address changes to ensure that you will receive Town information in a timely manner.

The Town has installed a post with reflective numbers for each address to ensure quick identification in the case of an emergency. If you did not receive an address sign, please call John Meyerhofer at (920) 582-4322.

PAPER

DO:

(Please place in paper grocery bags)
Fiberboard (12 and 24 pack soda and beer wraps,
cereal and cracker boxes, etc.)
Phone Books
Paperback & Hardcover Books
Newspaper (all sections)
Corrugated Cardboard
(boxes flattened)
Magazines & Catalogs
Junk Mail & Envelopes
Office & Writing Paper
Milk, Juice and Soup Cartons

DON'T:

Bathroom/Diaper paper
Gift Wrap
Tissue paper
Paper with food on it (pizza boxes)

DISPOSAL OF NEEDLES

Used needles are a hazard! They must **NOT** be placed in your trash or recyclables. Check with your medical provider or pharmacy. The Omro Community Center does offer this service.

ADDITIONAL ITEMS TO BE RECYCLED

Anti-freeze, Tires, Waste Oil, Yard Waste, Scrap
Metal, Appliances, Lead Acid Batteries,
Televisions, and Electronics.

PLANTING IN THE TOWN RIGHT OF WAY

Residents of the town are asked not to plant crops or ornamental plantings in the towns right of way. Our road side cutter will cut them off when he cuts the road side ditches. The towns right of way is the area approximately 33 feet from the center of the road. Any question about the right of way, contact Chairman Marty Johnson. Cultivating or other damage to the ditches that disrupts the flow of water requiring the town to clean out the ditches will be charged to the property owner responsible for the damage.

CONTROLLED BURNS

The burning of any structure in the Town of Poygan requires a burning permit issued by the Winneconne/Poygan Fire District. The Sheriff's department should also be notified of any controlled burns larger than the size of a campfire (brush, grass, etc.) The phone number to contact them at the start and end of the burn is 920-236-7300. Petroleum based products (tires, shingles, etc.) cannot be burned. Doing so can result in a fine from the Town of Poygan, the Department of Natural Resources or both.

ANIMAL LAND AND BUILDING REQUIREMENTS

Winnebago County Land and Water Conservation permits are required for buildings that will house stable animals. Town Zoning Ordinances also require specific lot sizes for stable animals. Properties housing farm/stable animals must register their premise with the State of Wisconsin.

SPRING CLEAN UP

As the snow melts and the sun starts to shine, we all have the desire to be outside. Ditches and public areas often gather debris over the course of the year. We would appreciate your help keeping our community clean and in picking up trash or debris when you see it.

BRUSH CLEARING

A sixteen-foot right away and a fourteen-foot overhead clearance are required for emergency vehicles to access a location. Please ensure that brush and other obstacles are properly removed to allow this access. The Town of Poygan also does brush cutting along Town roads for visibility and to ensure safety in the Town. Locations for brush cutting are determined based upon the need in a specific area and budget availability.
