Notice from the Town Clerk

The Town Clerk's office is warning residents of a scam that could cost them unnecessary funds.

Some residents have received the "Recorded Deed Notice" via mail from the scammer, "Property Site". The notification advises the property owner to obtain a copy of their Property Assessment Profile from the scammer for a fee of \$128.00. The notice includes a pay-by-telephone number. A response deadline creates a sense of urgency. A sample of the letter is below.

If you wish to receive a copy of your deed, you are able to do so from the Town Clerk's office.

Please do not send money to anyone regarding your property deed.
