## **Ordinance Index**

- A. The first digit(s) shall indicate the numerical sequence in which the ordinance was enacted.
- B. The last six digits shall comprise the date the ordinance was enacted, by day, month and year.
- C. A suffix letter "A" shall be added to identify an amendment to a previously enacted ordinance and a suffix letter "R" shall be added to identify an ordinance which repeals a previously enacted ordinance.

It is also resolved that the following listing of all ordinances now in the official record at the Town Clerk's office be assigned the numbers as indicated on said listing and that a copy of this entire resolution be entered into said ordinance record to indicate same.

It is further resolved that future ordinances enacted for the Town of Prospect be numbered in accordance with paragraph one of this resolution
