ORDINANCE NO. 08-05

AN ORDINANCE OF THE BOARD OF COMMISSIONERS OF THE TOWN OF REDINGTON BEACH, FLORIDA AMENDING CHAPTER 2, DIVISION 3. SUPPLEMENTAL CODE ENFORCEMENT PROCEDURE, SECTION 2-92(a), ENFORCEMENT JURISDICTION; BY PROVIDING FOR REPEAL OF ORDINANCE OR PARTS OF ORDINANCES IN CONFLICT HEREWITH AND PROVIDING FOR AN EFFECTIVE DATE.

ORDINANCE NO. 08-06

AN ORDINANCE OF THE BOARD OF COMMISSIONERS OF THE TOWN OF REDINGTON BEACH, FLORIDA AMENDING CHAPTER 6, ARTICLE I, SECTION 6-3 REMOVAL OF DEBRIS, EQUIPMENT, ETC., FOLLOWING CONSTRUCTION; RESTORATION OF SITE ON FAILURE TO COMPLETE CONSTRUCTION.

Attorney Lokenauth read the Ordinance by title. No discussion. Commissioner Drillick said the adoption of this Ordinance would set a time limit of 15 consecutive days for construction debris to be removed from the site. **Motion** made by Commissioner Drillick and seconded by Commissioner Fox to adopt at 1st reading.

Public comments were heard from residents Kimberly Butts, Gladys Rock and Ed Fernandez. Comments were made as to what is construction debris v. construction material; and the value of changing the time limit from 15 days to 30 days, discussion ensued. The original Motion was withdrawn. **Motion** made by Commissioner Drillick and seconded by Commissioner Fox to adopt Ordinance 08-6 as amended to read ... '**no more than 30 days after completion, or cessation for more than 30 consecutive days,....**
