a. Discussion of slow release fertilizers into the waterways. Attorney Salzman said that the Town would not need any ordinances, since Town's Comprehensive Plan has accepted the policy to promote slow release fertilizers. Board discussion ensued. Topics covered were the upcoming State legislation, Sierra Club letter, sample regulations for an island community and enforceability. Comments were heard from Ed Fernandez, Planning Board Chair as to Town already being endorsed by the Mayor's Green City Action Accord. Mayor Simons summarized, that we will go with educating the Public by making a promotional pamphlet for residents and information insertion into the Town Newsletter and Town web page.

ORDINANCES

ORD. 09-01

AN ORDINANCE OF THE TOWN OF REDINGTON BEACH, FLORIDA AMENDING CHAPTER 12, NUISANCES OF THE TOWN OF REDINGTON BEACH CODE OF ORDINANCES BY CREATING ARTICLE V, ABANDONED REAL PROPERTY; BY CREATING SECTION 12-111, DEFINITIONS; BY CREATING SECTION 12-112, DECLARING ABANDONED REAL PROPERTY TO BE A PUBLIC NUISANCE; BY CREATING SECTION 12-113, REGISTRATION OF ABANDONED REAL PROPERTY; BY CREATING SECTION 12-114, MAINTENANCE REQUIREMENTS; BY CREATING SECTION 12-115, SECURITY REQUIREMENTS; BY CREATING SECTION 12-116, ADDITIONAL AUTHORITY; BY PROVIDING FOR THE REPEAL OF ORDINANCE OR PARTS OF ORDINANCES IN CONFLICT HEREWITH; BY PROVIDING FOR SEVERABILITY; AND PROVIDING FOR AN EFFECTIVE DATE.

Attorney Salzman read the ordinance by title. Board discussion as to the definition of abandoned and vacant real properties. Attorney stated that the ordinance defines vacant (unoccupied and visibly not maintained) and abandoned properties as a 'nuisance'. The registration form was reviewed; having an ordinance in place provides enforcement of the registration form; the 'form' can be amended at any time without changing the ordinance. Question from Ed Fernandez, 161st Ave., was answered by Attorney, whether a vacant house, where power lines are pulled and toilets removed considered a nuisance? No perquisite if the town is maintaining it, yes it is a nuisance property. Mayor Simons said that as a coastal town with bay front properties we have a responsibility to maintain those properties, this is the intent of the ordinance. **Motion** by Commissioner Steiermann and seconded by Vice Mayor Deighton to adopt Ord. 09-01 at 1st reading. **Roll Call vote:**
