Public Safety – Commissioner Fox

- In discussion with 5th /3rd Bank, they said on accounts over 1 million dollars, the bank would pay interest at 35 basis point over Libor; accounts under 1 million dollars, it would pay 10 basis point over Libor. In addition they assured us that they would drop the FDIC maintenance charges.

ORDINANCE – 1ST Reading

ORD. 09-08

AN ORDINANCE OF THE BOARD OF COMMISSIONERS OF THE TOWN OF REDINGTON BEACH, FLORIDA AMENDING CHAPTER 5, BOATS, DOCKS AND WATERWAYS, ARTICLE III, BULKHEADS, DOCKS, ETC., IN BOCA CIEGA BAY, SECTION 5-57, SPECIFICATION FOR DOCKS, SUBSECTION (a)(5), BY PROVIDING FOR THE REPEAL OF ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT HERewith, AND PROVIDING FOR AN EFFECTIVE DATE.

Attorney Salzman read the ordinance by title. Commissioner Drillick said that in discussions with the County and Town Board of Adjustment it was determined that existing non-conforming docks that were permitted when originally built and now need repair and maintenance were still applying for a variance, this ordinance will clarify and eliminate the need for a variance. Opened to the Public, Joe Sheehnan, 4th St. asked about nonconforming docks that were not permitted. Attorney said these are special exceptions and it would go before the Board for consideration in a case-by-case basis. Public closed.
