AN ORDINANCE OF THE BOARD OF COMMISSIONERS OF THE TOWN OF REDINGTON BEACH, FLORIDA AMENDING CHAPTER 5, BOATS, DOCKS AND WATERWAYS, ARTICLE III, BULKHEADS, DOCKS, ETC., IN BOCA CIEGA BAY, SECTION 5-57, SPECIFICATION FOR DOCKS, SUBSECTION (a)(5), BY PROVIDING FOR THE REPEAL OF ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT HERewith, AND PROVIDING FOR AN EFFECTIVE DATE.

Attorney Sirico read the ordinance by title. Commissioner Drillick said that in discussion with the County, Mark Davis and Brd. of Adjustment, it was determined that it is simpler for the existing permitted dock owners who already received a variance, not to require a 2nd variance for repair and maintenance on these docks.
