PUBLIC FORUM – *David Drillick, 1st St.* – urged the Board to restrain from spending on capital expenditures due to the reassessment of County properties and decrease of revenue.

NEW BUSINESS

a. Pinellas County Planning Council- Executive Director David Healey and Chris Mettler Program Planner presented the Updated Determination of Consistency Plan to the Commissioners. County Resolution 10-40 was adopted by the County Planning Council as an updated determination of consistency for the Town of Redington Beach; in accordance with Chapter 88-464, laws of Florida as amended. Following a brief discussion and public comments, Board consensus was to have Chris Mettler check back with Town Clerk Patrus and Town Attorney Sirico and move ahead with this project. Initially it will not involve the Town Planning Board, until Town's zoning districts and future land use plan categories are correlated with the county land development regulations.

b. RBPOA, Request for use of Friendship Park – RBPOA President, Fatima Rapuano and Vice President Rosalee Yurasko were present. Letter of request for use of Friendship Park, was presented to the Board, in anticipation of holding several open air movies in 2010, beginning in May, weather permitting. Access to Town assembly hall was not requested, since the public rest room in maintenance building can be utilized. No discussion. **Motion** made by Commissioner Deighton and seconded by Commissioner Will to approve use of Friendship Park by RBPOA for Movies in the Park events in 2010.

Resolution 2010-04

A RESOLUTION OF THE BOARD OF COMMISSIONERS FOR THE TOWN OF REDINGTON BEACH, FLORIDA SUPPORTING PINELLAS COUNTY ORDINANCE NO. 10-06 REGULATING LANDSCAPE MAINTENANCE PRACTICES AND THE USE OF FERTILIZERS CONTAINING NITROGEN AND/OR PHOSPHORUS; AND PROVIDING FOR AN EFFECTIVE DATE.

Attorney Sirico read the Resolution by title. Mayor Simons said this Resolution supports the County Ordinance regulating the use of fertilizers containing nitrogen or phosphorous, which wash into the waterways, upsetting the ecosystems of the gulf and bay. As an NPDS requirement, Public Works Director Mark Davis, has requested that Board approve the Resolution. Brief Board discussion ensued on town swales, drainage and exempt golf courses. **Motion** made by Commissioner Deighton and seconded by Commissioner Will to adopt.
