Motion passed with five affirmative votes. Attorney will proceed.

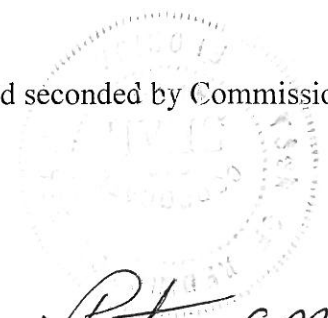
