 - a. **Property located at 16027 Redington Drive, REDINGTON BEACH HOMES 2ND ADDITION BLOCK 11, LOT 17**, as recorded in plat book 23 page 40 of the Pinellas County Property Appraiser's office, is requesting the Board of Adjustment to grant an exception for an increased impervious surface ratio of 59.3% to construct a new carport and driveway. Per Town Code 6-103(1), the impervious surface ratio must not exceed the allowable impervious lot coverage established in the Future Land Use Element of the Comprehensive Plan. The Town's current Comprehensive Plan allows for a maximum impervious surface ratio of 40% for single-family homes zoned in the RU (Residential Urban) zoning district.

- b. **Property located at 15713 Redington Drive, LONE PALM BEACH 2ND ADD BLK 18, LOT 20**, as recorded in plat book 20 page 72 of the Pinellas County Property Appraiser's office, is requesting the Board of Adjustment to grant an exception for an the installation of a boatlift on an existing, non-conforming dock.
