This is a matter Park Board will have to bring this to the Commissioners for approval. Does the town have insurance on parks? Tiffany will check with Adrianna on insurance. Friendship Park needs new outlets. Beach Park is a total loss. Dave Poole and David Will were assessing the area and plan to present to the Park Board on how to repair it. The board would like to see the concrete removed so at least it will look nicer than it is now. If concrete is removed and it is just sand/dirt so residents can park there. The soccer field needs to be tested for safety before anything is repaired there. Moon Park is destroyed. Priority would be 1. Friendship Park 2. Beach Park 3. Town Park 4. Moon Park

d. Lights-Angels went up this week and are working well. Tiffany called the company and got the price reduced since they installed a lot less lights than normal. Payment for the lights this year was \$5,635. Save close to \$10,000 dollars. 31 lights in total were charged.
