

**TOWN OF RICE LAKE, RESOLUTION #18-111
RESOLUTION AND NOTICE OF SPECIAL CHARGES**

**State of Wisconsin
Town of Rice Lake
Barron County**

The Town Board of the Town of Rice Lake, Barron County, Wisconsin, by this resolution, adopted by a majority of the town board on a roll call vote with a quorum present and voting and proper notice having been given, resolves and orders as follows:

A special charge in the amount of Five Hundred Dollars (\$500.00) to **Russell A. Mayfield (d/b/a St.LL, Inc)**, landowner in the Town of Rice Lake, for the following services made under s. 66.0627, Wis. stats.: Fire call by the Rice Lake Fire Department.

Charges and costs incurred by the Town of Rice Lake for the above-described special services were to have been fully reimbursed and paid by the landowner to the Town of Rice Lake by October 8, 2018. These special services were provided by the Town of Rice Lake or its agents on the following described real property in the Town of Rice Lake: 2026 22 ½ Avenue, Rice Lake, WI 54868 described as PLATS 7-2 & 8-1 N 16 RDS OF S 18 RDS OF E 10 RDS OF SW-NW EX CSM 26/126 #3791 & PRT SE-NW DESC IN VOL 361 PG 120, Section 9, Town of Rice Lake, Parcel #038-0900-09-000, owned by Russell A. Mayfield.

Being that the full amount of the special charge was not timely paid by October 8, 2018, the unpaid special charge shall be considered delinquent and shall become a lien on the above-noted real property as of the date of delinquency and shall be included in the current or next tax roll for collection and settlement by the Town of Rice Lake under chapter 74, Wis. Stats, along with interest at the rate of 18% per annum, from the date of invoice through December 31, 2018, for a total special charge of \$533.04 (Five Hundred Thirty-Three and 04/100 Dollars).


No public hearing and notice of public hearing was required regarding this special charge.

The town clerk shall serve this resolution upon the landowner by regular first class mail, as the town's notice to the landowner under s. 66.0627 (3) (a), Wis. stats.

The town clerk shall properly post or publish this resolution as required under s. 60.80, Wis. stats.

This resolution shall become effective as of January 1, 2018.


