

**TOWN OF RICE LAKE, RESOLUTION #19-116
RESOLUTION AND NOTICE OF SPECIAL CHARGES**

**State of Wisconsin
Town of Rice Lake
Barron County**

The Town Board of the Town of Rice Lake, Barron County, Wisconsin, by this resolution, adopted by a majority of the town board on a roll call vote with a quorum present and voting and proper notice having been given, resolves and orders as follows:

A special charge in the amount of Five Hundred Dollars (\$500.00) to **Clayton Grover**, landowner(s) in the Town of Rice Lake, for the following services made under s. 66.0627, Wis. stats.: Fire call by the Rice Lake Fire Department.

Charges and costs incurred by the Town of Rice Lake for the above-described special services were to have been fully reimbursed and paid by the landowner to the Town of Rice Lake by November 11, 2019. These special services were provided by the Town of Rice Lake or its agents on the following described real property in the Town of Rice Lake: 2183 18 ½ Avenue Lot 8, Rice Lake, WI 54868 described as GL 1-3A & PLAT 16-2A THAT PRT OF GOVT LOT 1 & THAT PRT SE-SE SHOWN AS PCL B CSM 3/36 #225 EX LOT 1 CSM 8/109 #1028 (THIS IS ANDERSON TRAILER COURT), Section 34, Town of Rice Lake, Parcel #038-3400-28-000, owned by Clayton Grover.

Being that the full amount of the special charge was not timely paid by November 11, 2019, the unpaid special charge shall be considered delinquent and shall become a lien on the above-noted real property as of the date of delinquency and shall be included in the current or next tax roll for collection and settlement by the Town of Rice Lake under chapter 74, Wis. Stats, along with interest at the rate of 18% per annum, from the date of invoice through December 31, 2019, which amounts to Twenty-Seven Dollars and 50/100 (\$27.50), for a total special charge of Five Hundred Twenty-Seven Dollars and 50/100 (\$527.50).


No public hearing and notice of public hearing was required regarding this special charge.

The town clerk shall serve this resolution upon the landowner by regular first class mail, as the town's notice to the landowner under s. 66.0627 (3) (a), Wis. stats.

The town clerk shall properly post or publish this resolution as required under s. 60.80, Wis. stats.

This resolution shall become effective as of January 1, 2019.


