## **TOWN OF RICE LAKE, RESOLUTION #22-118**

## A RESOLUTION FOR AMERICAN RESCUE PLAN ACT (ARPA) ALLOCATION

State of Wisconsin Town of Rice Lake Barron County

Whereas, the American Rescue Plan Act ("ARPA") established the Local Fiscal Recovery Fund ("LFRF"), which distributes funds ("ARPA Funds") to provide continued relief from the impact of the COVID-19 pandemic; and

WHEREAS, the ARPA program appropriates funds to assist, state, local, tribal and territory governments in responding to the COVID-19 pandemic; and

WHEREAS, the Town of Rice Lake has been notified of ARPA funding in the amount of \$323,007.16, payable in two tranches; and

WHEREAS, the Town of Rice Lake is in receipt of the first tranche in the amount of \$161,557.85 on June 25, 2021, and the second tranche in the amount of \$161,557.85 was received on June 21, 2022; and

WHEREAS, the Federal Treasury has issued final guidance on how the Town can utilize the funding, with funds having to be obligated by the end of 2024 and spent by the end of 2026; and

WHEREAS, the Coronavirus State and Local Fiscal Recovery Funds provide needed fiscal relief for recipients that have experienced revenue loss due to the onset of the COVID-19 public health emergency; and

WHEREAS, the Treasury presumes that up to \$10 million in revenue has been lost due to the public health emergency and recipients are permitted to use that amount (not to exceed the award amount) to fund "government services"; and

WHEREAS, Recipients may elect a "Standard allowance" of \$10 million to spend on government services through the period of performance; and

WHEREAS, All recipients may elect to use this standard allowance instead of calculating lost revenue using the formula provided by US Treasury, including those with total allocations of \$10 million or less; and

WHEREAS, the Town of Rice Lake has the need to fund government services while in the recovery phase of the COVID-19 pandemic.

NOW, THEREFORE BE IT RESOLVED, that the Town Board of the Town of Rice Lake, Barron County, Wisconsin, does hereby authorize ARPA funding be applied to the following expenditures:

➤ Hazard pay shall be paid to all election workers for hours worked between April 2020 and April 2021 with said hazard pay being the equivalent of 50% of the total wages paid. Payment was made to election workers on April 12, 2022 with the total being \$2,891.46.

- Hazard pay shall be paid to all employees of the town who faced undue hardship and risk while performing their work duties. The Town Board approved a set amount of \$10,000.00 to be distributed to five employees based on hours worked, risk factor, and pay scale. With the employers share of social security, medicare and Wisconsin Retirement contributions added, the final total was \$11,215.53 and was paid on September 1, 2022.
- Road infrastructure improvements consisting of:

23rd St. between CTH C and 22nd Ave. (1 mile)	\$141,999.63
23 <sup>rd</sup> St. from 22 <sup>nd</sup> Ave. north 0.7 miles (0.70 miles)	\$ 92,189.08
20½ St. between STH 48 and 23½ Ave. (1 mile)	\$ 74,711.46
