WHEREAS, Section 59.69(5)(e), Wis. Stats. provides that if a town is affected by a proposed zoning amendment, it must take certain action as provided for therein; and

WHEREAS, the Town Board for the Town of Rice Lake, located in Barron County, Wisconsin, has considered the Petition and the associated requested zoning change with respect to the Property.

NOW, THEREFORE, BE IT RESOLVED by the Town Board for the Town of Rice Lake as follows:

That the Town Board recommends approval of the petition, but subject to the following conditions:

1. That the Town Clerk transmit a copy of this Resolution to the City of Rice Lake Extraterritorial Committee in accordance with applicable provisions of law.
