**NOTICE INVITING BIDS**

Notice is hereby given that the Township of Rice Lake, Barron County, Wisconsin, will receive sealed bids for the construction project identified herein, in accordance with the requirements of this Invitation to Bid (ITB).

**PROJECT IDENTIFICATION**

24th Ave from 21st St (offset 1320) to 22nd St for a total of 3960 feet.

**SCOPE OF WORK**

Work to be completed is: Complete pulverization of the existing road and lay 2.5" (compacted) X 22' of warm mix asphalt with a 2' shoulder.

All bids must follow the LRIP guidelines.

All bids must include an Engineer's Certification of a 10-year design life in accordance with LRIP guidelines.

**PROJECT COMPLETION REQUIREMENT**

All work under this contract shall be fully completed on or before October 15th, 2026, unless otherwise extended in writing by the Township of Rice Lake.

**PLANS AND SITE INFORMATION**

Prospective bidders are encouraged to review site conditions prior to submitting a bid. Voluntary site visits may be arranged.

**BID SUBMISSION REQUIREMENTS**
