### **Where Does Your Wood Go? Markets Near & Far—Scott Lyon**

Scott is a Department of Natural Resources Forest Products Services Specialist, and has worked in a new position covering 26 counties in eastern Wisconsin since June 2014. He provides assistance to forest products companies and private individuals, including marketing and technical support, manufacturing process efficiency studies, and wood utilization and marketing plans for trees affected by invasive species, disease, or storm damage. In his spare time he enjoys hiking with his wife, hunting, and Civil War reenacting.

### **Invasive Species & How to Deal With Them—Scott Neuman**

Scott is the Operations Manager at Integrity Lawn Service & Supply. Scott has been working to identify and control invasive species that affect our woodlands and wetlands on both public and private lands for over a decade. He specializes in finding abatement solutions for difficult areas through forestry mowing and chemical applications. Scott and his team are licensed by the state to apply regulated chemicals to help control unwanted species. His work takes him from the southern most part of the state to islands in Lake Superior. Scott is an avid Hunter and conservationist who enjoys teaching others.

### **Red Pine Management: When to Thin, How to Thin & Management Options—Andy Noth**

Andy is a Department of Natural Resources Forester serving Manitowoc County. Andy provides forestry assistance to private woodland owners and manages the forest resources of Point Beach State Forest. He enjoys hunting, camping and traveling with his wife and two daughters.

### **Current Forest Health Issues—Bill McNee**

Bill is the Department of Natural Resources Forest Health Specialist for southeast Wisconsin and is stationed in Plymouth. He has worked in the DNR Forest Health Program since 2001. He primarily works with the detection and management of invasive insects such as emerald ash borer and gypsy moth, but also provides landowners with native pest and disease advice.

### **Oak Management: Harvesting Options—Don Peterson**

Don, President of Renewable Resource Solutions, LLC, is a consulting forester. Don is Chairman of the Wisconsin Consulting Forester Association and Administrator of the Wisconsin Master Logger Certification Program.
