Resolution No. 04-2021 TB "Approval of Door County Supervisory District Plan And Establishment of Wards"

WHEREAS, the Door County Board of Supervisors' held a public hearing concerning the Preliminary County of Door Supervisory District Plan on September 21, 2021; and

WHEREAS, The Preliminary County of Door Supervisory District Plan was approved by the County Board on September 21, 2021; and

WHEREAS, the Preliminary County of Door Supervisory District Plan has been received by and reviewed by the Town Board of Supervisors as required by Wis. Stats. 5.15;

NOW THEREFORE, BE IT RESOLVED by the Town Board of Supervisors of the Town of Sevastopol, Door County, Wisconsin, that the Preliminary County of Door Supervisory District Plan be and is hereby approved.

BE IT FURTHER RESOLVED that the Town of Sevastopol establishes 5 (Five) Wards described as follows:

Town of Sevastopol Ward 1 – Commencing at the Northeastern corner of the Southwestern one-quarter of the Northwestern one-quarter of Section 20, T28N-R26E, thence Southerly to the Southwestern corner of the Southwestern one-guarter of the Northwestern one-guarter of Section 29, T28N-R26E, thence continue Southerly approximately 283 Feet, thence Easterly approximately 657 Feet, thence Southerly approximately 565 Feet, thence Westerly approximately 653 Feet to the West line of said Section 29, thence Southerly to the Southwest corner of Section 29, T28N-R26E, thence continue Southerly approximately 428 Feet, thence Westerly approximately 542 Feet, thence Southerly to the centerline of Gordon Rd, thence Westerly along the centerline of Gordon Rd to the intersection with the centerline of Bay Shore Dr, thence Southerly along the centerline of Bay Shore Dr to the South line of Government Lot #2 of section 31, T28N-R26E, thence Easterly to the East one-quarter corner of said Section 31, thence Southernly to the Southwest corner of the Southwesterly one-quarter of the Southwesterly one-quarter of Section 32, T28N-26E, thence Westerly along the boundary lines of the City of Sturgeon Bay to the shore of Green Bay, thence Northerly along the shore of Green Bay to the Northwestern corner of Government Lot 1, thence Easterly approximately 1227 Feet to the Northeastern corner of Government Lot 1, thence Southerly approximately 1303 Feet to the centerline of W Dunn Rd, thence Easterly along the centerline of W Dunn Rd to the point of beginning.

Town of Sevastopol Ward 2 – Commencing at the Northwest corner of the Northwest one-quarter of the Northwest one-quarter of Section 21 T28N-R26E, thence Southerly along the centerline of W Dunn Rd to the Northwest corner of the Southwest one-quarter of the Northwest one-quarter of Section 21, thence Westerly along the centerline of W Dunn Rd to the Northwest corner of the Southwest one-quarter of the

Northwest one-quarter of Section 20 being the intersection of W Dunn Rd and County Highway HH, thence Southerly along the centerline of County Highway HH to the West one-quarter corner of Section 29, T28N-R26E, thence continue Southerly approximately 283 Feet, thence Easterly approximately 657 Feet, thence Southerly approximately 565 Feet, thence Westerly approximately 653 Feet to the West line of said Section 29, thence Southerly to the Southwest corner of Section 29, T28N-R26E, thence continue Southerly approximately 428 Feet, thence Westerly approximately 542 Feet, thence Southerly to the centerline of Gordon Rd, thence Westerly along the centerline of Gordon Rd to the intersection with the centerline of Bay Shore Dr, thence Southerly along the centerline of Bay Shore Dr to the South line of Government Lot #2 of section 31, T28N-R26E, thence Easterly to the East one-quarter corner of said Section 31, thence Southerly approximately 766 Feet to the City of Sturgeon Bay limits, thence Easterly and Northerly around the City of Sturgeon Bay boundary limits to the intersection of the centerline of Egg Harbor Rd and Old Highway Rd, thence along the centerline of Old Highway Rd to the intersection with the centerline of Gordon Rd, thence Easterly along the centerline of Gordon Rd to the centerline of State Highway 42-57, thence Northeasterly along State Highway 42-57 to the Northwest corner of the Northwest one-quarter of the Southwest one-quarter of Section 27, T28N-R26E, thence Easterly along the centerline of State Highway 57 to Southeast corner of the Southwest one-quarter of the Northwest onequarter of Section 26, T28N-R26E, thence Northeasterly along the centerline of State Highway 57 to the intersection of State Highway 57 and County Highway PP, thence Westerly along the centerline of County Highway PP to the point of beginning.

Town of Sevastopol Ward 3 – Commencing at the Northeast corner of the Northeast one-quarter of the Northeast one-quarter of Section 14, T28N-R26E, thence Westerly along the centerline of W Whitefish Bay Rd to the intersection of Bluff Dr and W Whitefish Bay Rd, thence Northerly along the centerline of Bluff Dr to the West one-quarter corner of Section 8, T28N-R26E, thence Northerly along the centerline of Bluff Ct to the Northwest corner of the Northwest one-quarter of the Northeast one-quarter of Section 8, T28N-R26E, thence Westerly along the centerline of Bluff Ct to the centerline of Bay Shore Dr, thence Northerly along the centerline of Bay Shore Dr to the intersection between Little Harbor Dr and Bay Shore Dr, thence Westerly along the centerline of Bay Shore Dr to the to the Southeast corner of Lot 10 of Little Harbor Point Plat, thence West to the shore of Green Bay, thence Southerly along the shore of Green Bay to the Northwest corner of Government Lot 1, thence Northeasterly along Government Lot 1 to the Southwest corner of the Northeast one-quarter of the Northeast one-quarter of Section 19, thence Easterly follow the centerline of W Dunn Rd to the Southeasterly corner of the Southeasterly one-quarter of the Southeasterly one-quarter of Section 16, thence Easterly along the centerline of County Highway P to the Southeasterly corner of the Southeasterly one-quarter of Section 14, thence Northerly along the centerline of N County View Rd to the point of beginning.

Town of Sevastopol Ward 4 – Commencing at the Northeast corner of the Northeast one-quarter of the Northwest one-quarter of Section 6, T28N-R27E, thence Easterly along the centerline of W Townline Rd to the shore of Lake Michigan, thence Southerly along the shore of Lake Michigan to the Southeasterly corner of parcel 0220331282743C, thence Westerly approximately 152 Feet along the parcel boundary line, thence Northwesterly approximately 222 Feet to the Centerline of County Highway T, thence Westerly along the centerline of County Highway T to the intersection between State Highway 42-57 and County Highway T, thence Northerly along the centerline of State Highway 42-57 to the intersection of Egg Harbor Rd and State Highway 42-57, thence Westerly along the centerline of Egg Harbor Rd to the

intersection of Egg Harbor Rd and Old Highway Rd, thence Northeasterly along the centerline of Old Highway Rd to the intersection of Gordon Rd and Old Highway Rd, thence Easterly along the centerline of Gordon Rd to the intersection of Gordon Rd and State Highway 42-57, thence Northeasterly along the centerline of State Highway 42-57 to the intersection between State Highway 42-57, State Highway 42, E Jorns Ln, and State Highway 57, thence Easterly along the centerline of State Highway 57 to the Southeasterly corner of the Southwestern one-quarter of the Northwestern one-quarter of Section 26, T28N-R26E, thence Northeasterly along the centerline of State Highway 57 to the intersection of State Highway 57 and County Highway P, thence Westerly on the centerline of County Highway P to the intersection of County Highway P and N Country View Rd, thence Northerly along the centerline of N Country View Rd to the intersection of Clark Lake Rd and N Country View Rd being on the Northwest corner of the Northwest one-quarter of Section 12, T28N-R26E, thence Easterly to the Northwest corner of the Northwest one-quarter of the Northwest one-quarter of Section 7, T28N-R27E, thence Northerly along the centerline of Leist Rd to the Northeast corner of the Northeast one-quarter of the Northwest one-quarter of section 6, T28N-R27E, thence Easterly along the centerline of W Townline Rd to the point of beginning.

Town of Sevastopol Ward 5 – Commencing at the Northeast corner of the Northwest one-quarter of the Northeast one-quarter of Section 6, T28N-R27E being the intersection of Leist Rd and W Town Line Rd, thence Southerly along the centerline of Leist Rd to the Southeast corner of the Southwest one-quarter of the Southwest one-quarter of Section 6 being the centerline of Clark Lake Rd, thence Westerly along the centerline of Clark Lake Rd to the Northwest one-quarter of the Northwest corner of the Northwest one-quarter of Section 12 being the intersection of Clark Lake Rd and N Country View Rd, thence Southerly along the centerline of N Country View Rd to the Northwest corner of the Northwest one-quarter of the Northwest one-quarter of Section 13 being the intersection of N Country View Rd and W Whitefish Bay Rd, thence Westerly along the centerline of W Whitefish Bay Rd to the Southwest corner of the Southwest one-quarter of the Southeast One-quarter of Section 8 being the intersection of W Whitefish Bay Rd and Bluff Ct, thence Northerly along the centerline of Bluff Ct to the Northwest corner of the Northwest onequarter of the Northeast one-quarter of Section 8, thence Westerly along the centerline of Bluff Ct to the intersection with the centerline of Bay Shore Dr, thence Northeasterly along the centerline of Bay Shore Dr to the centerline of Little Harbor Dr, thence Northwesterly along the centerline of Little Harbor Dr to the Southeast corner of Lot 10 of Little Harbor Point Plat, thence West to the shore of Green Bay, thence Northerly along the shore of Green Bay to the North line of Section 6, T28N-R26E, thence East along the North line of said town to point of beginning.

BE IT FURTHER RESOLVED that the Town Hall, located at 4528 State Highway 57, Sturgeon Bay, Wisconsin, shall be official polling place for the Town of Sevastopol Wards 1 (One), 2 (Two), 3 (Three), 4 (Four) and 5 (Five) of the County of Door Supervisory District Plan.

NOW, THEREFORE, it is hereby resolved that the Town Board of the Town of Sevastopol does hereby adopt the foregoing resolution.
