5. Ordinance Amendment #1-2017 authored by the Planning and Development Committee. The ordinance amendment will repeal Article 9, Shoreland Protection Provisions of Chapter 9 of the Oneida County Zoning and Shoreland Protection Ordinance. These revisions are due to 2015 Wisconsin Act 55, 2016 Wisconsin Act 167 and 2016 Wisconsin Act 319. The provisions of Article 9 are commonly called shoreland protection provisions and apply to structures and properties within 1,000 feet of the ordinary high water mark of a lake and/or 300 feet from the ordinary high water mark of a navigable river or stream.

The ordinance amendment will also be adding definitions and modifying existing definitions to Article 10 – Definitions.
