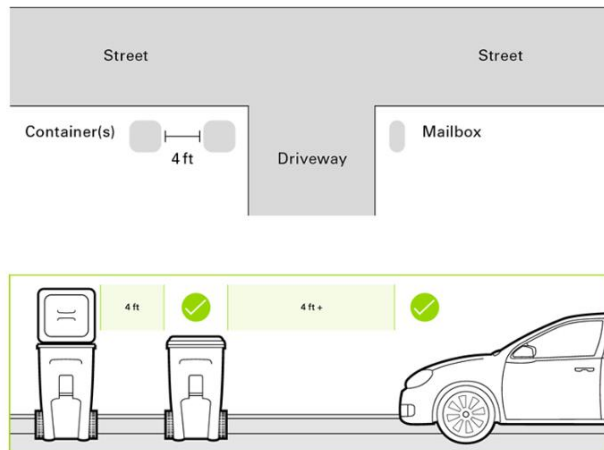

GFL Environmental will deliver (1) garbage and (1) recycling cart to each residence. If you want an additional cart(s), call GFL for direct billing at 920-685-0771. **DO NOT USE GFL CARTS UNTIL JANUARY 1, 2024.**

DECEMBER 27, 2023: Waste Management will have the final garbage/recycling pickup. Use the existing carts. After this collection, **LEAVE YOUR EMPTY, CURRENT GARBAGE & RECYCLING CARTS BY THE ROAD TO BE REMOVED.**

Effective January 1, 2024, GFL will be our primary residence hauler and only their carts should be used at this point going forward. Please set the carts out as the diagram shows below by 6am the day of collection. The schedule will stay the same, just a different hauler. A calendar is enclosed, and there should also be one included with the new carts during delivery.

FIRE SIGNS ARE FOR YOUR SAFETY



Town of Utica Fire Signs are placed near each driveway around the ditch/culvert area which is the Town's road right-of-way. These are placed for the Fire & EMS volunteers and Ambulance Service to find your home during an emergency. Especially while it is dark, since the signs are reflective. If you moved or removed the fire sign, please put it back. These signs and posts are the property of the Town of Utica. Please contact a Town Board member if you have any questions or concerns.

In 2024, there is a Referendum for Clerk/Treasurer of Utica to change from Elected to Appointed. Here are some facts for you before you vote.

Appointed

- Do not have to be a town resident.
- Qualifications/jobs/wages are set by Town Board.
- Cannot be removed during their term unless there is cause.
- The board can choose to not re-appoint at the end of the term without cause.
- Term for appointed is 3 years, then board decides to re-appoint or dismiss.

Elected

- Must be resident of Town of Utica.
- Answer to the town but are not required to have specific qualifications.
- Can be recalled from office just like appointed.
- Term for elected is 2 years, then needs to be voted on again by towns people.
