1. Call the Meeting to Order

Chairman Schmick called the meeting to order at 5:30pm

- 4. Public Forum: Opportunity to comment about an Agenda item or new business; say your name & address (no action taken by the Board)

Joan Newell asked if retired volunteer firemen still have the privilege of using the Town Hall? Chairman Schmick feels they should be like an active member; 1 free rental per year. Joan also asked what the contract detail is for the cleaning people (Pioneer Cleaning), what do they do? Feels they are not fulfilling their contract. There are times the toilets are not clean and other things are not being cleaned, if it's part of the detail. She comes in prior to rentals to make sure the Hall is in order. Clerk Sonnleitner retrieved their 2009 contract and they were sent a reminder in 2014 of their contract services as a reminder what should be done. Supervisor Sawall asked that photos be taken so we can address the issue.

Walt Whiting asked what is all the surveying going on in the Town? Chairman Schmick is unsure. Supervisor Sawall said the next time he sees them, he will ask. Walt also asked about ditch mowing; Fisk, Knott, James to 44 and other roads. Chairman Schmick said many roads have not been mowed. The State insists the State Roads be mowed first and the County hasn't gotten to the town roads yet, there are 4 machines down too. Chairman Schmick said he would be interested in having the roadsides sprayed to stunt the growth. Supervisor Sawall talked with Mike Nemitz and the tractors need to be fixed first and then they will get to the Town roads. Walt also asked about Agenda #11 regarding Insurance on 1997 new-to-us truck. Chairman Schmick said it's the truck Ripon Truck gave us to use until we get our new one.

Kevin Fritz mentioned the County still has ARPA funds, possibly get some of those funds to pay for the fire truck or are there other grants that could be applied for to help pay for the fire truck? Chairman Schmick isn't sure about any other funds or grants received.

Patsy Beck believes the fire dept has tried everything to get funds. Interested in the Ambulance Service, as a First Responder in this township, we are in a crisis now. Chairman Schmick explained the IGA and progress made already. The Town is required to provide ambulance service. The ambulance district is working on a feasibility study and received an Innovation Grant. There is a deadline this month as to what towns will be a member of this Intergovernmental Agreement. We received 3 bids.

Eric Whiting asked what Legacy Lens Photo Booth is? Chairman Schmick stated the resident in Imperial Hills would take pictures by appointment and wanted to know if that was okay and told him he didn't think it would be a problem. Eric asked about Class B on James Road between 91 and 44. What will that change with the truck traffic? Patsy Beck has traveled James Road almost daily and the truck traffic is terrible. Chairman Schmick stated he called the State and they don't have it posted for the trucks to go that way. The trucks can travel James Road with an empty load, but shouldn't with a full load, if using the road as a short-cut. No difference for a resident that has property on that road.

Patsy Beck mentioned the Stop sign in Imperial Hill. Supervisor Sawall said the sign is up, should stop from both directions before getting onto 44. Chairman Schmick said it took awhile to call Diggers Hotline and order the sign.

Eric Whiting asked about the Class "B". Clerk Sonnleitner said the convenience store has a Class A license meaning alcohol can be purchased, but consumed off the premises. "Class B" is what Jasper's and Wehrmann's has, consuming beverages onsite. Class "B" would be just the beer, it's not a reserve license. The reserve license we had was sold to the

Town of Nepeuskun. Eric is asking if the convenience store is wanting more than "B" as he believes the Town of Algoma has extras that they could be asked to buy one of theirs. Eric asked what the dog bite incident is about? Chairman Schmick stated we received a letter from a resident's attorney regarding a dog bite.

William Santiago stated with the limited amount of space for traffic and space is shared with another business, and his home, he is concerned about this property having a liquor license. Will this increase traffic? Doesn't see how this will benefit the community to sit and consume beverages. What about the safety of others from those consuming when they leave this building? Chairman Schmick said the property currently is not legal, there are requirements that aren't being met. Public Forum closed

## 5. BUDGET: Any 2025 Amendments

Chairman Schmick motions we approve this budget amendment 2025-07, a resolution changing the 2025 Budget the Town of Utica, Wisconsin be it resolved that the Town Board of the Town of Utica follows that the sum of \$190 from Health and Human Services account be transferred to Legal; seconded by Supervisor Sawall. Carried 2-0

6. License request from Pickett Country Market for a Class "B" Beer at 6644 State Road 44 in the lounge room for Sukhdeep Garcha and Rajwinder Singh.

Clerk Sonnleitner talked with a representative with the Alcohol Beverage department with Dept of Revenue and Pickett Country Market needs to dedicate an employee to that space, and a separate entrance is needed, a door needs to be constructed. There should be two separate entities. There are overlap issues, it would need to be like a restaurant. At this time, Pickett Country Market is not in compliance. Raj stated he needs to put a door there but is checking on the availability of receiving the license, don't need it now. Raj stated this would be for the people eating their fish fries there, they can sit there to eat and have a drink. Clerk Sonnleitner said the application was completed by Raj but parts are incomplete. If he was given the license now, the DOR representative would ask Raj to surrender the license. If that didn't happen, then the Town Board would be told to revoke the license, which is more involved. The recommendation was to get the space in compliance first. Clerk Sonnleitner stated when the space is ready and we receive notice from the DOR that he is in compliance, return the completed application. There would be the publication fee with notice requirements and the fee for the license.

7. Legacy Lens Photo Booth: 1741 Cottontail Dr.

Chairman Schmick motions that we allow Legacy Lens to use their home for a business; seconded by Supervisor Sawall. Carried 2-0

8. Dog bite incident

Chairman Schmick will contact the Constable to see if there are any prior problems with that dog. Treasurer Hunter reached out to the attorney and Constable Kalies, the dog is not licensed.

9. WINNEBAGO COUNTY: Chapter 27 Shoreland Zoning Code update

Chairman Schmick attended the meeting. Chairman Schmick motions to let the County do what they have been doing, that we would approve it; seconded by Supervisor Sawall. Carried 2-0

## 10. ROADS:

A) Maintenance

Chairman Schmick said the County did the bare minimum this year to fill cracks and potholes. If anyone knows of any, let him know. Received calls from people in Imperial Hills regarding low branches. He talked with the property owner asking to trim those branches. We will see what happens. Legally we can cut branches 50 feet from the edge of the road.

Supervisor Sawall motions that we do a value of the loaner truck to \$900,000; seconded by Chairman Schmick. Carried 2-0
