A Resolution Permitting The Operation of Snowmobiles On Town-Owned Properties

The Town Board of the Town of Utica, Winnebago County, Wisconsin, resolves as follows:

WHEREAS, the Sno-Scats Snowmobile Club marks trails crossing across some Town-owned roads, and

WHEREAS, the location of this proposed snowmobile trail would be as depicted on the Winnebago County trail map attached, and

NOW, THEREFORE, BE IT RESOLVED, by the Town of Utica Town Board hereby designates the snowmobile trail as depicted on the map attached, and

BE IT FURTHER RESOLVED, that the designation of this snowmobile trail is subject to the following conditions:

- 1. The Sno-Scats Snowmobile Club shall groom and maintain this trail
- 2. The Sno-Scats Snowmobile Club shall be responsible for all trail signages and markings,
- 3. The Sno-Scats Snowmobile Club's trail grooming and maintenance equipment shall not drag snow, ice, or other materials across the driving lanes or shoulder surface
- 4. Vehicular access to this trail shall be limited to snowmobiles and trail grooming and maintenance equipment
- 5. Any damages to Town property resulting from this use shall be repaired or restored to its original state as soon as practicable
- 6. The Sno-Scats Snowmobile Club shall provide a current certificate of liability insurance to the Town prior to any use of this trail
- 7. The Sno-Scats Snowmobile Club shall obtain all authorizations and approvals from private property owners and public entities prior to the use of this snowmobile trail
- 8. All parties using this snowmobile trail shall adhere to the standards of operation established by Wis. Stats. Ch. 350 and the Wisconsin Department of Natural Resources
- 9. This trail designation shall expire on April 30, 2026, and

BE IT FURTHER RESOLVED, that this trail may be reviewed for designation as a snowmobile trail on an annual basis at the request of the Sno-Scats Snowmobile Club, which shall submit a written request for trail designation to the Town Chairman no later than October 1 of any year in which the trail designation is sought, and

BE IT FURTHER RESOLVED, that the Town Clerk is hereby directed to send a copy of this Resolution to the Wisconsin Department of Natural Resources, the Winnebago County Sheriff's Department, and the Town of Utica's Volunteer Fire Department.


