AN ORDINANCE AMENDING ORDINANCE 2019-02, as Amended on June 10, 2021,
through Ordinance 2021-02

An Ordinance allowing All-Terrain Vehicles
(ATV) and Utility Terrain Vehicles (UTV)
on certain Roads and Highways within the
Town of Wescott boundaries

WHEREAS the Town of Wescott adopted Ordinance No. 2019-02, Allowing ATV-UTV vehicles on certain Roads and Highways within the Town of Wescott, on August 8th, 2019 and amended the Ordinance on June 10, 2021; and

WHEREAS the Town of Wescott has agreed, at the request of the Wisconsin Trail Lake Runners, Inc., to open an ATV trail on State Highway 22 ROW between Ash Circle and Cedar Lane.

NOW THEREFORE, the Town Board of the Town of Wescott ordains as follows:

1. Section 2: Statutory Authority will be amended to read: This ordinance is enacted under the authority of §§ 23.33(8)(b) and (c), 23.33(11) and 60.22 (3), Wis. Stats. The provisions of § 23.33, Wis. Stats., and the provisions of Wisconsin Administrative Code NR 64 regulating ATV and UTV operations and containing applicable definitions are hereby adopted and incorporated into this Ordinance as though set forth in full herein.
2. Section 5A: Routes will be amended to read: Section 5: Designated Routes and Trails: Town Roads: All Town Roads are designated as ATV routes unless posted as closed. The Town designates a non-roadway corridor of State Highway 22 ROW between Ash Circle and Cedar Lane as an ATV/UTV trail subject to permit approval from the Wisconsin Department of Transportation.
3. Section 6: Signage (a) will be amended to read: Routes shall be marked with uniform ATV route signs in accordance with § NR 64.12(7), Wis. Admin. Code.
4. All other provisions of Ordinance No. 2019-02, as amended through Ordinance 2021-02 will remain the same.
